Subject: Cross-Jurisdictional Planning & Zoning Matrix and Medical Marihuana

A growing number of cross-jurisdictional plans and regulations —many at the county or regional level— cover portions or all of Hillsdale County and affect its local governments. These need to be acknowledged and incorporated into all pertinent local plans and zoning regulations. R2PC staff has developed the following matrix for Hillsdale County municipalities for that purpose. Keep it handy for the next time you update your local master plan or zoning ordinance. Of course, R2PC planners are also available and eager to guide your community through the planning and zoning processes.
