**ITEM 4            AGENCY STATUS REPORTS**

Project status updates were reviewed by the City of Jackson, Jackson Area Transportation Authority, Jackson County Department of Transportation, the Michigan Department of Transportation, Jackson County Airport – Reynolds Field, and the Fitness Council of Jackson. Members were encouraged to visit the Enterprise Group’s website to view their report.

Chair Michalsky informed the committee that two of his Rural-STP projects were dropped from the October MDOT bid letting as result of MDOT running out of obligation authority in mid-July. Because the rural funds no longer carryover to the next fiscal year the JCDOT lost over \$950,000 for the Moscow and Lansing Avenue projects. Discussion followed regarding the changes to the rural funding program and that MDOT keeps modifying the process. Questions were asked regarding ensuring that 25% of the obligation authority went to the locals. Ms. Dewey stated that she would check on this.

Mr. Maurer stated that the airport was receiving \$9.5 million through the FAA discretionary funding.

**US-127 (Parnell Road to Henry Road) – Work is complete**

**I-94-BL (Glick WB @ Mechanic St.)-** This is a project under design from our signal unit, scope and time is unknown. No further updates are known at this time.

**FY 2015**

**I-94 (OV Parma Rd, UN Gibbs Rd, OV Blackman Rd.)** - Shallow and deep concrete overlays, full depth deck patches, concrete T-beam repairs, substructure repairs, bridge railing repairs, approach work, partial painting, thrie beam railing retrofit, concrete surface coating and traffic control. Maintaining traffic is currently under design/discussion. Project is delayed until 2016.

**FY 2016**

**M-50 (US-127 NB entrance ramp) to Napoleon Rd.** - HMA cold milling and 2 course overlay with joint repairs, intermittent curb and gutter replacement, minor drainage improvements, and intersection improvements. Letting and scope are yet to be finalized.

**I-94 BL/W. Michigan Ave. (Brown St. to Washington / Louis Glick)** – Full concrete pavement roadway reconstruction with water main, lighting and sidewalk replacement. Design progressing, coordinating with the City of Jackson on replacement decisions.

**M-50 (Ganson to North and Michigan to Wildwood)** – Full pavement reconstruction with drainage and other improvements. Design engineering firm being selected; contract to combine with I-94 BL project. Portions will probably be built in the spring of 2017

**FY 2017**

**M-60 (Emerson to Renfrew)** – HMA cold milling and 2 course overlay with joint repairs, intermittent curb and gutter replacement, minor drainage improvements and intersection improvements. Design engineering firm will be selected in the fall of 2014. Project survey work is nearing completion.

### Federal Funds Obligated in Fiscal Year (FY) 2014

As the state-designated Metropolitan Planning Organization (MPO) for the Jackson urbanized area, the Region 2 Planning Commission (R2PC) is responsible for developing and managing a 20-year Long Range Transportation Plan and a short-term (4-year) Transportation Improvement Program (TIP). The current edition of the TIP includes a listing of the approved road, highway, bridge, transit, and non-motorized projects scheduled to receive federal and/or state funds in Jackson County during the 2014 to 2017 Fiscal Years.

Federal legislation adopted in July 2012, and continued through May 2015, **Moving Ahead for Progress in the 21<sup>st</sup> Century (MAP-21)**, continues the requirement of past legislation that “*an Annual List of projects, for which federal funds have been obligated in the preceding year shall be published or otherwise made available by the metropolitan planning organization for public review. The listing shall be consistent with the categories identified in the Transportation Improvement Program.*”

Therefore, in response to the above directive, R2PC is pleased to provide a list of all the projects in Jackson County “obligated” during FY 2014 (October 1, 2013 to September 30, 2014). The Federal Highway Administration (FHWA) defines “obligated” as the federal government’s legal commitment to reimburse the implementing agency for the federal share of a project’s eligible costs. Although not all obligated projects were initiated or completed during this fiscal year, they have been approved by FHWA for reimbursement in FY 2014. Some projects actually constructed in FY 2014 were obligated in previous fiscal years and will not appear on this listing.

Hi Pam,

I know that you are tired of this, but I have a lot of people asking me questions that I don't have answers for. You have assured me that 25% of the obligation authority was spent on local agencies, but I haven't seen anything that confirms this. But, what I want to know is if the local agencies actually spent the 25% of the obligation authority, then several agencies spent more than their allocations. How are you handling this? Will the agencies that overspent have the amount of overspending deducted from their 2015 allocation? If so, where will this money go? If not, then agencies could continue to overspend while other agencies that run into problems with their projects will continually lose money. Please explain to me how this makes the program more sound or financially constrained.

Hi Susan,

Per the conversation we had a month or so ago, please note the following:

1. We are required by law to divide federal aid 75% state 25% local. The local program was not short-changed in any way. I am copying Eric Mullen, our revenue specialist if you want to verify the numbers.
2. At the end of July, our Bureau of Finance notified MDOT Local Agency Programs and our section that obligation authority had been expended.
3. Per the conversation we had, I informed you the majority of the local transportation agencies in the state do not cap their projects. The majority are funded pro-rata which means if there are cost overruns or high bids for projects, 80% of those costs are eligible to be covered by federal aid. This spends the available revenue and obligation authority faster and makes it difficult for projects being submitted later in the year to receive all of their federal aid.
4. Projects are processed on a first come – first serve basis
5. It's my understanding that bids for projects were coming in anywhere from 14 to 20% around the May/June/July timeframe this year which is the time of year when the majority of fiscal year

projects are being obligated. This has not happened in several years (bids were coming in low during the recession), but it did this fiscal year.

6. Because of the expenditure of old balances during FY 2013, there is no longer a “cushion” in the local program. This means the only money available to expend is the money that is allocated on an annual basis and it means that obligation authority will be spent faster. Michigan has 83 counties and the local program consists of urban and rural projects all vying for the funds and spending authority in the local pot.
7. If that wasn’t enough, FHWA also required the finance bureau to close out old jobs and remaining balances during FY 2014. This also used FY 14 obligation authority which reduced the amount available to fund jobs coming in.

On the rural side, several task forces are discussing the option of capping the federal aid assigned to their projects. This means that if there are cost overruns or high bids exceeding the programmed amount, the local agency would be responsible for the difference and would not jeopardize the funding of others’ projects if they are submitted later in the year.

This could work in theory, however if the majority of local agencies still opt not to cap their projects, then obligation authority could still be exhausted before the end of the fiscal year. Projects have always been processed on a first come, first serve basis and this is why we have always advised agencies to get their projects in earlier in the fiscal year rather than later.

MDOT LAP contacts the MPOs when bids are significantly higher than the programmed amounts in the TIP so that additional funding can be added to the project prior to obligation or the project can be re-prioritized. For rural projects outside of MPOs, it is up to the local agency to decide if they accept the higher bid or not. Perhaps we can develop a better process to notify the task forces in the future, but for now this is the system we have in place.

You keep asking me how am I personally going to prevent obligation authority from running out during the fiscal year. I can assure you, I don’t control how or when local agencies submit their projects or the bidding process. My responsibility is to provide the best information I can, make sure the projects are on the TIP and constrained to the funding available. I wish I had more super powers, but I don’t. 😊
