#### ITEM 6 APPROVAL OF THE JACTS UNIFIED WORK PROGRAM

Mr. Duke informed the committee that the Unified Work Program, included in the packet, consisted of the same funding and activities as prior years. The only difference is that a new FY 2017-2020 TIP will be prepared in FY 2016. He also stated that the Federal Highway Administration and the federal Transit Administration are focusing on three essential areas:

- 1. <u>Performance based planning</u> MPOs will be required to set reasonable targets for different performance areas and then work towards addressing that target. He stated the small MPOs are working together to develop performance measures as a group.
- 2. Regional approach to transportation planning Crossing county lines.
- 3. Access to essential services Identifying gaps in current services.

The motion was made by Mr. Brittain, supported by Mr. Feldvary, to approve the JACTS FY 2016 Unified Work Program and budget as submitted. The motion carried unanimously.

## ITEM 7 APPROVAL OF PROPOSED AMENDMENTS TO THE JACKSON COUNTY NATIONAL FUNCTIONAL CLASSIFICATION (NFC) NETWORK

Ms. Richardson stated that this exercise is required every 10 years and that the reason is to take a look at your roads and determine if they are classified as they are functioning. If there are no new developments or businesses, there will not be many changes. She informed the committee that Ganson Street, from Cooper Street to Horton Street, will be taken off the National Highway System because of low annual average daily traffic. She also reviewed other reclassifications of area roadways and the upgrading of three local streets.

The motion was made by Mr. Feldvary, supported by Mr. Moilanen, to approve the NFC changes as presented. The motion passed unanimously.

#### ITEM 6 APPROVAL OF THE JACTS FY 2016 UNIFIED WORK PROGRAM

Mr. Duke stated that the draft FY 2016 Unified Work Program had been included in the Technical Advisory Committee agenda packet for review and comment. He explained that the work program contained many of the same activities that are routinely completed by the MPO. In FY 2016, staff will complete a new FY 2017-2020 Transportation Improvement Program (TIP). The plan also includes activities related to incorporating performances measures; ensuring a regional approach to transportation planning by promoting cooperation and coordination across transit agency, MPO, and state boundaries; and improving access to essential services. The proposed budget for FY 2016 remains the same as the funds budgeted in FY 2015.

The motion was made by Mr. Ripstra, supported by Mr. Maurer, to approve the JACTS FY 2016 UWP as presented. The motion carried unanimously.

# ITEM 7 APPROVAL OF PROPOSED AMENDMENTS TO THE JACKSON COUNTY NATIONAL FUNCTIONAL CLASSIFICATION (NFC) NETWORK

Mr. Duke explained that after every decennial U.S. Census and adjustments have been made to the urbanized area boundary, the FHWA requires that the states work with appropriate officials to review and update the National Functional Classification (NFC) system of roadways. R2PC, in conjunction with representatives from the City of Jackson and the Jackson County Department of Transportation met and reviewed the current federal-aid eligible roads based on AADT, changes in business and industry along the route, the roadway characteristics, and local knowledge of the roads functions. Mr. Duke briefly reviewed the changes and updates proposed for the NFC map.

The motion was made by Mr. Rand, supported by Mr. Fowler, to approve the proposed amendments to the Jackson MPO National Functional Classification (NFC) system map as presented. The motion carried unanimously.

#### ITEM 7 OTHER BUSINESS

Chair Michalsky stated that the TEDF-F applications are due back to MDOT by June 1<sup>st</sup> and that JCDOT is reviewing possible projects for submission. Applications for MDOT's High Risk Rural Roads funding are due back at MDOT in mid-August.

Ms. Torres discussed assisting Lomar Industries with a TEDF-Category A grant application to solicit funds for improvements to Coates Road. Chair Michalsky offered to assist Ms. Torres in the preparation of a letter of intent.

Mr. Gulock reported that the Context Sensitive Solutions committee next meeting will be held in October. A public meeting is planned for May 27<sup>th</sup> to discuss the FY 2016 reconstruction of I-

#### FY 2015

**1-94 (OV US-127/M-50)** - Full paint, concrete surf coat. CPM. Project was justified and is moving forward with a start date of July  $6^{th}$ .

**I-94 EB & WB – Grass Lake Weight Scales**, Expand concrete parking pad for chase vehicles. Work is being completed by MDOT forces.

#### FY 2016

**I-94 (OV Parma Rd, UN Gibbs Rd, OV Blackman Rd.) -** Shallow and deep concrete overlays, full depth deck patches, concrete T-beam repairs, substructure repairs, bridge railing repairs, approach work, partial painting, thrie beam railing retrofit, concrete surface coating and traffic control. Currently finishing up final plans. Expect to hold OEC Meeting in late July/early August.

**I-94 (M-99, Michigan Ave, EB & WB over Concord Road, Dearing Rd, Sandstone Rd, Airport Rd)** - Deck patching, joint replacement, epoxy overlay, partial paint, steel and concrete beam repairs, steel beam high load hit repairs, substructure repairs, approach work, barrier rail patching and maintaining traffic. Currently finishing up final plans. Expect to hold OEC Meeting in late July/early August.

**M-50** (**US-127 NB entrance ramp**) **to Napoleon Rd. -** HMA cold milling and 2 course overlay with joint repairs, intermittent curb and gutter replacement, minor drainage improvements, and intersection improvements. Final plans are complete and ROW has been certified. The OEC Meeting will be held in August.

**I-94 BL/W. Michigan Ave. (Brown St. to Washington / Louis Glick)** – Full concrete pavement roadway reconstruction with water main, lighting and sidewalk replacement. Continuing to work on plan development. Right-of-Way acquisition will begin this summer. Project may be built in 2017.

**M-50** (Ganson to North and Michigan to Wildwood) – Full pavement reconstruction with drainage and other improvements. Design progressing contract to combine with I-94 BL project. Continuing to work on plan development. Right-of-Way acquisition will begin this summer. Project will most likely be built in 2016, prior to the Michigan Avenue project.

M-60 (EB & WB OV I-94), (PE, SUB & ROW) – Bridge Replacement Project scope is under development.

#### FY 2017

**M-60** (Emerson to Renfrew) – HMA cold milling and 2 course overlay with joint repairs, intermittent curb and gutter replacement, minor drainage improvements and intersection improvements. Project design will begin fall 2015.

M-60 (Chapel Rd to Emerson Rd) - Rehabilitation and intermittent reconstruction including widening for center left-turn lane between Chapel Road and Dearing Road; drainage improvements, sidewalk upgrades and possible non-motorized work. Project design will begin fall 2015.

**I-94** (Michigan Ave. to Dearing Rd.), (PE & ROW) – Reconstruction Project scope is under development.

#### **JATA PASSENGER SURVEY**

#### **OVERVIEW**

The intent of this document is to provide a summary of passenger input gathered through a survey of passenger satisfaction and use of the JATA system. Passenger input is of highest value to JATA. The information contained in this report will be used in combination with results of a comprehensive public survey, which will be submitted separately. This document is presented to JATA as a draft technical memorandum and will become part of the draft final report in the Market Research Study.

#### PASSENGER SURVEY METHODOLOGY

The JATA passenger survey was conducted February 7-13, 2015. A team of two surveyors from Jackson and two JATA employees were trained by the RLS & Associates, Inc. (RLS) on-site survey manager to collect surveys from passengers as they boarded the vehicles. Two RLS employees also collected surveys. The survey team surveyed all routes.

Surveyors wore badges to identify them as official JATA Surveyors. They were provided with trip log sheets with the bus stops and schedules for the trips that they were covering. Surveyors were stationed at the JATA Transit Center. Surveyors then boarded buses or stayed at the Transit Center to collect surveys. Each route was surveyed (weekday and Saturday) so as not to discriminate against any certain location within the JATA service area.

The survey instrument was developed with input from the JATA Project Manager. It included questions about passenger demographics as well as trip origins and destinations, and the level of satisfaction with existing JATA services. The data not only provides insight into customer service trends, but also offers the necessary data measurement of service to minority and low-income populations to ensure compliance with Title VI of the Civil Rights Act of 1964 and Executive Order: EO 12898 for addressing environmental justice.

At the onset of the survey planning stage, the survey sampling plan had a goal confidence interval of +/- 10 percent with a 95 percent confidence level at the systemwide level. A total of 397 valid surveys were completed. With this sample, the survey results have a confidence interval of approximately three people, meaning that approximately every third person would respond similarly to the survey results provided for each question.

#### **PASSENGER SURVEY RESULTS**

The following paragraphs and charts illustrate the overall systemwide survey results.

#### **Geographic Distribution of Survey Responses**

JATA passengers were asked to report the zip code where they live. This response provides JATA with information about the geographic distribution of survey respondents. The distribution of 316 total responses to the question is listed below and illustrated on the map in Exhibit 1.


