

### **2040 LONG RANGE TRANSPORTATION PLAN**

*"The 2040 Long Range Transportation Plan for the Jackson Area Comprehensive Transportation Study is a vision of the area's transportation system through the year 2040. The transportation improvements in the first four years (2014-2017) of the Plan are considered firm commitments by the implementing agencies. This means that the improvements in the first four years will be completed unless unforeseen circumstances prevent completion. The remaining years of the Plan are a vision of how the transportation system may develop based on the existing master and zoning plans of the cities and townships in Jackson County, transit development programs, and the current projections of available revenues. The transportation improvements in the later years (2018-2040) represent current priorities for the future. The Long Range Transportation Plan is updated every five years and the priorities for the later years can and will change as conditions warrant."*
