In 2000 I made first contact with the Jackson County Rd Comm, regarding the Moon Lake Rd bridge needing replacing. It is not the proper width for today's standards. It was built in 1942, and had one side completely knocked off from a fatal accident in the 1980s. I was told then that perhaps the following year.

The following year dirt was filled in around the bridge and that was it. I contacted the Road commission, and they said they were working on it.

Then 911 happened, and I repeatedly got the budgets are forever changed by 911, and other such excuses.

In 2005 I made contact again, I was told to get letters in to them. Which I did.

In 2006 I was told to again get letters. I circulated a petition getting over 500 signatures, and turned it in to the Road Commission.

In 2008 -2011 I called them and got the same story over and over that they are applying for grants.

2011, 2012, 2014, Leoni Township sent resolutions to the Jackson County Road Commission, grants were applied for and they were denied.

In 2015 I made contact again, and was told, yes its next, we had to squeeze in Hague Rd. Hague does not cross a chain of Lakes. It was much newer and wider than Moon Lake. But Hague was busy due to the college. So we accepted that, and we were assured 2016 was the year, finally.

In Feb 2016 I contacted again, and was told, no its going to be 2019.

The bridge currently is a one lane, with crumbling gravel falling into the boats underneath. Its very dangerous on a very busy waterway. Its a busy road with semis avoiding the weigh station of 94.

In March 2016 I started a social media page, called Napoleon Facts and Figures. The project featured right now since its beginning, is the Moon Lake Bridge. Within 2-3 days of starting the page, there are over 600 members. The comments are on the page for you to see the large interest in getting this project under way. We have waited our turn, understanding during the economy fall out, but we now feel if we are ever to get our values up again on our properties, we have to invest in the infrastructure. This project is beyond emergency, it needs to be done, you can see the water through it.

Please find a way to get this project funded, certainly there are loans and notes we can secure somewhere to get this done. So much money is being spent on all these beautification projects and walking trails, and fairground ideas, when our roads and bridges are a disaster. I have put three windshields in vehicles in the last 4 years. We had to trade in a very nice Ford Edge, that had the entire front end redone after hitting a pothole vs a head on. The repairmen never could get the shaking and pulling out so we traded it in. And now another chunk of pavement hit me right by my home, crashing my windshield. I cant afford the car damages we have had the last four years due to a terrible kept area of roads. This is a priority to the public.

County road commission obligations for roads

What is a township's obligation to maintain county roads?

A township has no legal obligation to maintain or repair county roads. In addition, there is no legal requirement for a township to match funds expended by a county road commission for either maintenance or construction of county roads.

Roads

This section is excerpted from an article that appeared in the April 1994 issue of the Michigan Township News.

Road maintenance and improvement can be one of the most expensive and time-consuming services demanded by township residents. It can also be one of the most frustrating, because townships have little authority over roads.

However, many townships successfully provide their residents with safe and well-maintained roads through a combination of planning and coordination with county road commissions and state agencies.

Before 1931, the construction of roads was a duty and burden imposed on townships by the Michigan Constitution of 1850. In those horse and buggy days, roads were considered strictly a local concern.

With the advent of the motor vehicle, highways became a matter of general public importance, which generated transferring responsibility to the larger governmental units, including counties and the state. A constitutional amendment in 1893 permitted the Legislature to establish a county road system. Through subsequent legislation, the authority to construct and maintain roads was gradually removed from township jurisdiction and placed under the authority of county road commissions and the state transportation department.

The progressive removal of township road authority culminated in the McNitt Act of 1931 and Public Act 51 of 1951 (MCL 247.651-247.675), which required Michigan county road commissions to take over all township public streets and alleys outside the limits of incorporated cities and villages as either county primary or local roads.

Currently, a county road commission may relinquish by resolution the jurisdiction of a road to a township. If the township board accepts, it becomes a township road. This is the only statutory provision that creates a township road. In cases where a public road for some reason has not been taken over by the county road commission, that fact does not place any duty or obligation on the township with respect to maintenance, repair or improvement of the road.

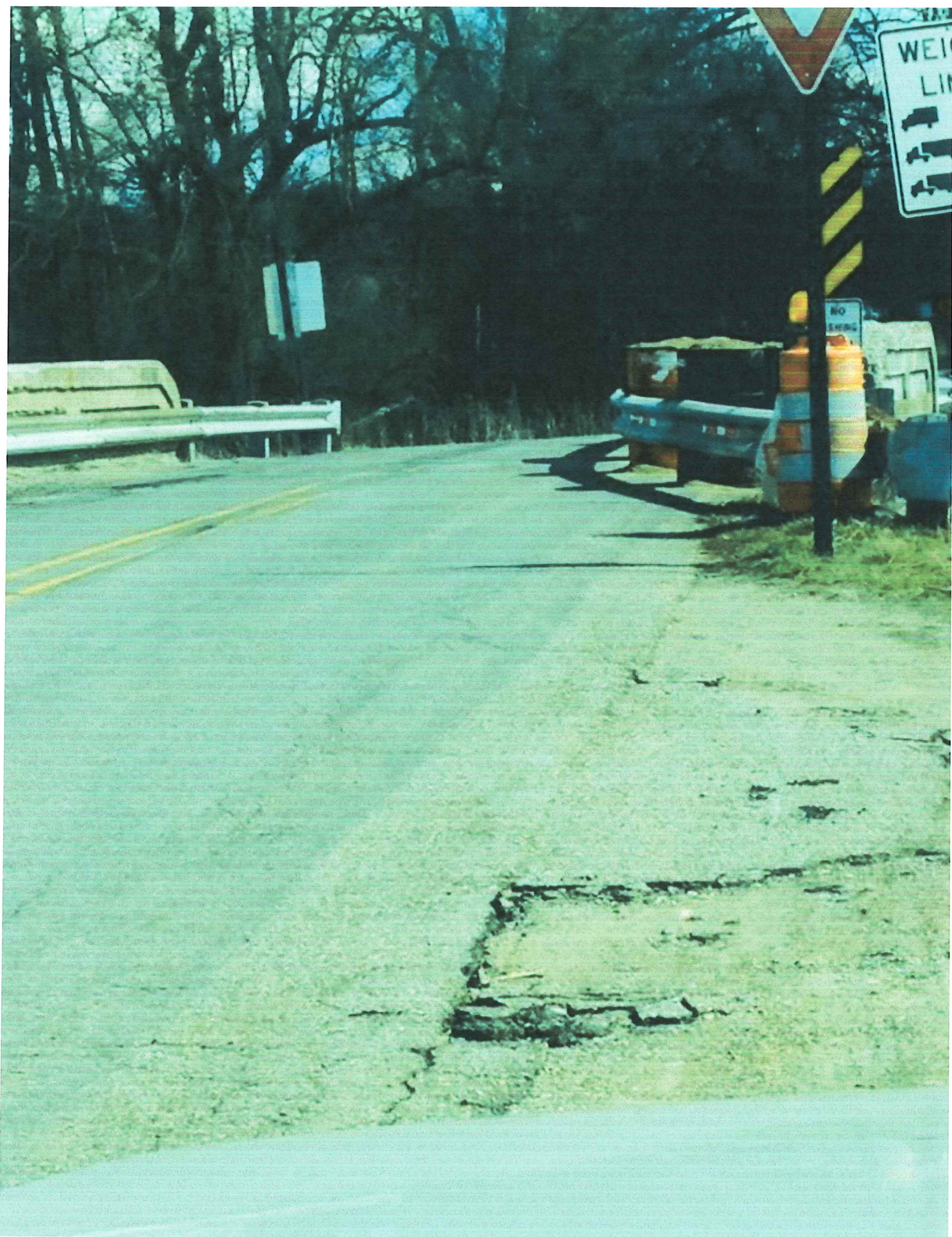
County road commission obligations for roads

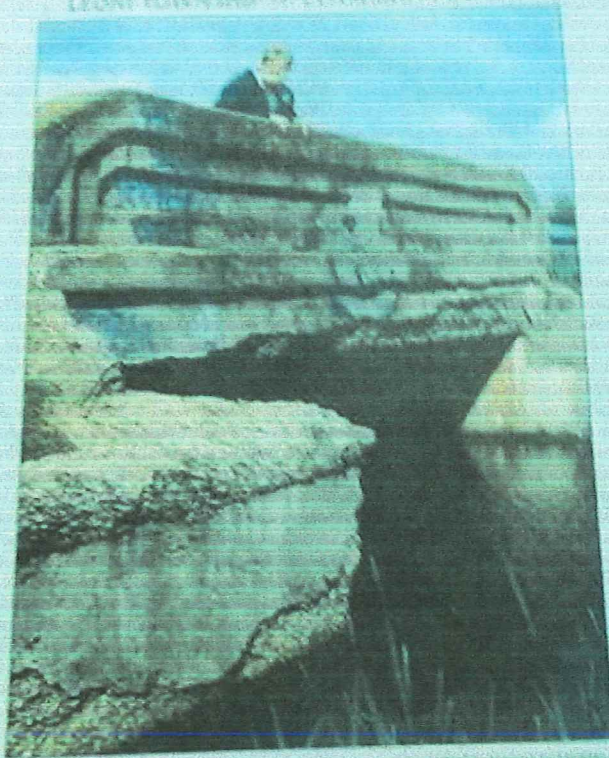

Building a better bridge

Local effort seeks money from state

Teresa Canine wants to build a bridge to unite residents along a chain of local lakes. She can't do it herself, but a petition she signed may yield money to make it happen.

Next week the Jackson County Road Commission will submit more than 200 signatures and its own grant application to the state to replace the Moon Lake Road bridge in Leoni Township.

The Michigan Department of Transportation will make a decision in November.

Five bridges span the bridge, which separates Leoni and Clinton townships, near the shore of Canine's property. It is the only bridge with a petition to replace it.

The Jackson County Road Commission will submit more than 200 signatures and its own grant application to the state to replace the Moon Lake Road bridge in Leoni Township.

The Michigan Department of Transportation will make a decision in November.

"The people from Michigan Center would like to go down to 'May Lake' where it's a lot better. And the water is good," she said. "And people from Wolf would like to come up to the other end where all the nature is."

Canine grew up on the Little Mud end of the chain and now lives closer to the other end, with a view of Michigan Center Lake from her Moon Lake Road home.

Replacing the bridge, built in the mid-1950s by the Works Progress Administration, is not just a recreational effort for a local concern, Canine said. A handful of people have been seriously hurt and even died over the years because of its old structure.

In 1984, Michigan, the road commission's sponsor, sent preliminary estimates for the bridge. It was estimated to cost \$1.5 million, but the state work can be done with funding it assured.

ate Mrs. Canine's effort in this, and the state will be a big help in the road building fund for the bridge.

The bridge is located near the boundary of Leoni and Napoleon townships, and officials from both agree on the need for work.

It James Phelps, Leoni Township's supervisor, said his board passed a resolution supporting reconstruction.

"It is in favor of getting it done. It's a hazard," he said. "But getting enough money will be the problem."

Napoleon Township Supervisor Dennis Deane signed Canine's petition even though her government has no direct influence over the bridge.

The condition of the bridge is a real concern, Deane said. "No matter what happens, I'm glad to see it replaced."

The road commission will be available through other state departments.

Whatever happens, Canine sees it as a good thing.

We have two kids that are grown up. They have their own homes and are not here to help us.

ITEM 1 CALL TO ORDER

Mr. Shotwell called the meeting to order at 8:01 AM. A quorum was present.

ITEM 3 APPROVE MINUTES OF THE POLICY COMMITTEE MEETING OF MARCH 17, 2016 AND RECEIVE THE TECHNICAL ADVISORY COMMITTEE MEETING MINUTES OF MARCH 8, 2016

The motion was made by Mr. Johnson, supported by Mr. Jancek, to approve the Policy Committee meeting minutes of March 17, 2016 and to receive the Technical Advisory Committee meeting minutes of March 8, 2016 as presented. The motion carried unanimously.

ITEM 4 AGENCY STATUS REPORTS

Project status updates were reviewed by the City of Jackson, Jackson Area Transportation Authority, Jackson County Department of Transportation, Michigan Department of Transportation, and Jackson County Airport – Reynolds Field.

City of Jackson – Wisner St. project preconstruction meeting is scheduled for April 5th, with work starting in mid-April. Lansing-Ganson signal will be complete end of April or early May (currently waiting on Consumers Energy to hook up signal). Kibby Rd. has begun surveying, and will no longer be a boulevard. Fourth St. has also started surveying. Blackstone sewer project is being finished and will be paved at the end of April. A question about Kibby Rd. and passing of safety vehicles was asked, they will have room to pass. Also asked about was the configuration of the Denton/Kibby intersection. This will most likely be a roundabout.

JATA – Mr. Moilanen reviewed all of the vehicle purchase and building upgrade projects in the packet, informing the group that all vehicles have been received. Also there was a question about JATA starting the Dial-A-Ride service again in the county, but this may not be happening after all.

Jackson County DOT – A list of new FY 2018-2020 Draft TIP projects are included in the staff report. There is a funding application for the Moon Lake Rd. bridge, which may be open for this summer. Mr. Duke asked about the Fifth St. project press release, Ms. Kline will be getting this information out. There was also an inquiry about lowering speed limits on Dearing Rd. to 45 MPH, Mr. Michalsky said that requires traffic counts and an application to the police.

MDOT – Mr. Grazioli reviewed the included projects. I-94 bridge repairs at several interchanges will begin in mid-April. Dearing Rd. guard rail will be moved to improve sight distance. M-60 will be patched until FY 2018, but will be a major improvement. There are also two safety projects for US-127 at Floyd and M-50 at Murray.

Jackson County Airport – Tree removal on Maynard is now complete, and the landfill hauling has resumed. Fill dirt will be brought in from Sandstone Township. Dust and trucks have become a big problem for Sandstone Township, Mr. Feldvary will look into it.

ITEM 5 **JACTS LONG RANGE PLAN UPDATE – TRAVEL DEMAND MODEL DEVELOPMENT PROCESS**

Mr. Dawson explained the progress of the travel demand model and informed the committee of the pertinent dates. This will be monitored by Region 2 Planning staff and MDOT Urban Travel Demand unit.

ITEM 6 **MICHIGAN AVENUE RECONSTRUCTION UPDATE, MDOT, JACKSON TSC OFFICE**

Mr. Grazioli reviewed project maps for the two-way conversion project in downtown Jackson. The highlighted intersections were the Glick/Washington/Michigan intersection and the Cooper/Glick/Michigan intersection. The design challenges and likely solutions were discussed and presented.

ITEM 7 **MDOT CALL FOR PROJECTS – FY 2017 HIGH RISK RURAL ROAD PROJECT APPLICATIONS**

Included in the meeting packet was a copy of the FY 2017 High Risk Rural Road project application. Mr. Duke informed the committee that anyone intending to apply for this funding should submit before April 29th. Funding for the program is estimated at \$2,000,000.

ITEM 8 **APPROVAL OF THE RESOLUTION CERTIFYING THE JACKSON URBANIZED AREA PLANNING PROCESS FOR FY 2017**

Mr. Duke presented the resolution to annually self-certify the JACTS planning process and affirm that the MPO has fulfilled the FHWA and FTA rules and regulations. Mr. Dunn made a motion to approve the resolution as presented, which was supported by Mr. Brittain. The motion passed unanimously.

ITEM 9 **OTHER BUSINESS**

- FHWA – Mr. Lanum briefly discussed the UWP program and the expected changes that will be coming.
- MDOT – Mr. Lanum discussed the future of performance measures in the MPO, and how they would work for a smaller MPO like Jackson. He also discussed the included “Fast Facts” data for 2016. Mr. Duke informed the committee that the MDOT TIP amendment that was not approved by the Policy Committee was approved by Region 2 Planning Commission, and will be added to the TIP.

ITEM 4 AGENCY STATUS REPORTS

Project status updates were presented by the City of Jackson, Jackson Area Transportation Authority, Jackson County Department of Transportation, Michigan Department of Transportation, and Jackson County Airport-Reynolds Field. Copies of the agency status reports were included in the meeting packet. Some highlighted items:

- City of Jackson – Wisner St. project work should begin in mid-April. The Lansing/Ganson signal work is underway and will be completed in approximately one month. Mechanic St. project is in the June letting.
- JATA – the one El Dorado has been delivered and is being painted now. The other vehicles ordered should arrive this month. The ADA compliant software is planned to start in August 2016.
- JCDOT – Robinson Rd. is in the May 6th letting. Fifth St. streetscape project has been approved by Amtrak and will begin in 1 to 2 weeks. Rives Junction Rd. non-motorized trail and pedestrian signals have just been approved as safety projects by MDOT.
- Several MDOT projects have been updated with work start dates. Two new safety projects have been added with “M” funds (US-127 at Floyd and M-50 at Murray).
- Jackson County Airport – an update was included in the meeting packet.
- The Enterprise Group is currently working with Jackson County GIS, Region 2 Planning Commission, and several other agencies to continue to identify and prepare large business sites in the county. The Jackson fundraising campaign is almost complete at 92% of the total goal.

ITEM 5 JACTS LONG RANGE PLAN UPDATE – TRAVEL DEMAND MODEL DEVELOPMENT PROCESS, MDOT

Mr. Kent and Mr. Mayle presented the finalized JACTS Travel Demand Forecast Model development schedule. This timeline highlights the critical dates that the MPO will have to take action on the various stages of model development. The four stages that require action are: review and approval of base year socioeconomic data, review and approval of future year socioeconomic data, approval of recommended project list, and approval of the modeling chapters of the LRTP document. The process should be completed by the December 2017.

ITEM 6 MICHIGAN AVENUE RECONSTRUCTION UPDATE – MDOT JACKSON TSC

Mr. Pittman and Mr. Grazioli presented the current plans for the Michigan Avenue reconstruction and two-way conversion of Washington and Glick. There will also be a redesign of the Cooper/Glick signal and intersection to accommodate the two-way switch. After reviewing the design and answering questions, Mr. Duke asked if there would be another public meeting after the latest design change. Mr. White stated that the design concerns from the first meeting were addressed and that there was no need for another public meeting. The designs have been approved by the City of Jackson and MDOT. Ms. Torres stated she was very impressed with the new design of Michigan Avenue.

ITEM 7 **MDOT CALL FOR PROJECTS – FY 2017 HIGH RISK RURAL ROAD PROJECT APPLICATIONS**

2012

Trail St at Railroad Crossing (Local Safety Program) – Construct non-motorized crossing and bridge sidewalk repair. MDOT contract is finalized. City received the payment from the bond company. Final work to be completed in the Spring.

2015

Wisner: Argyle to Boardman (Cat F) – Mill and resurface with new sidewalk on the east side. Hubbell, Roth and Clark (HRC) is the City's consultant. Michigan Paving and Materials is the contractor. **Construction started April 25, 2016 with the fire hydrant relocation and pavement removal of the intersection of Argyle started May 2.**

Lansing-Ganson Signal (Urban) – New box span signal with a south bound left turn lane add. FTC&H is the City's Consultant. Bids received in September, Bailey Excavating is the contractor. **Construction started March 21, 2016 and paving is scheduled to be placed by May 6. The new signal is operational and is currently on flash until paving is completed.**

2016

Mechanic: Morrell to Washington (Urban) - Reconstruction with water main replacement. DLZ is the City's consultant. **Project is in the June letting.**

2017

Kibby Road: City Limits to West Ave (Urban) - Reconstruct pavement with curb repairs on boulevard islands and curb replacement on outside lanes to reduce pavement width to one lane. MSG is the City's consultant. **Survey is almost complete and the City met with County Park staff to discuss coordination of the path projects with the road work being planned.**

2018

Fourth Street: Horton to Audubon (Urban) – Roadway resurfacing with a new roundabout at Hickory and Fourth. MSG is the City's consultant. **Survey is scheduled in the next several weeks. Roadway and path construction need to work with a group planning to install a disc golf course between Fourth Horton and Hickory.**

FY 2016

I-94 (OV Parma Rd, UN Gibbs Rd, OV Blackman Rd.) - Shallow and deep concrete overlays, full depth deck patches, concrete T-beam repairs, substructure repairs, bridge railing repairs, approach work, partial painting, thrie beam railing retrofit, concrete surface coating and traffic control. Project was let in December and will start in early May.

I-94 (M-99, Michigan Ave, EB & WB over Concord Road, Dearing Rd, Sandstone Rd, Airport Rd) - Deck patching, joint replacement, epoxy overlay, partial paint, steel and concrete beam repairs, steel beam high load hit repairs, substructure repairs, approach work, barrier rail patching and maintaining traffic. Project was let in December and will start in early May.

M-50 (Napoleon Rd. to Stoney Lake Drain) – One course mill and resurfacing. Anticipated start mid-May.

M-50 (Ganson to North and Michigan to Wildwood) – Full pavement reconstruction with drainage and other improvements. Ganson to North portion underway with through traffic detour. Stage completion estimated for the end of May.

Lansing Ave over I-94-Bridge repair due to a high load hit this fall. Project is a partial deck replacement and beam repairs. Project was let in December and will start in in early June

The Jackson County Department of Transportation is hereby requesting approval from the Region 2 Planning Commission Committee, JACTS Technical Advisory & JACTS Policy Committees concerning the following Transportation Improvement Program (TIP) Amendments for FY 2014 – 2017:

1. **FY 2017—Add:** Non-Motorized Multi Use Pathway on Rives Junction Road from M-50 (Clinton Road) to Township Line; Total Cost--\$277,780; Safety Funds--\$222,224; Local Match--\$55,556
2. **FY 2017—Add:** Countdown Pedestrian Signals—Airport Road/Springport Road/County Farm Road; Total Cost--\$101,200; Safety Funds--\$80.960; Local Match--\$20,240

Proposed work for Rives Junction Road will be to construct a ten (10) foot wide bituminous non-motorized multi use path along the west side of the road from M-50 (Clinton Road) to the north end of the Northwest School properties. Proposed work for the Airport Road/Springport Road/County Farm Road intersection will consist of installing Accessible Pedestrian Signals (APS) countdown pedestrian signals, especially for the benefit of the nearby assisted living centers where their mobility is often challenged by the size and complexity of the intersection.
