ITEM 1 CALL TO ORDER

Vice-Chair Jancek called the meeting to order at 8:07 AM. A quorum was present.

ITEM 2 PUBLIC COMMENT

Mr. Overton introduced Ms. Snyder, who is working with Jackson County administration as an intern.

ITEM 3 ELECTION OF JACTS TECHNICAL ADVISORY COMMITTEE VICE-CHAIR

Mr. Dawson informed the Board that Ms. Kline had been nominated for the position of Vice-Chair of the Technical Advisory Committee. Mr. Jancek requested a motion to confirm the appointment. Mr. Brittain made a motion, which was seconded by Mr. Acker. The motion was passed unanimously.

APPROVE MINUTES OF THE POLICY COMMITTEE MEETING OF JULY 21, 2016 AND RECEIVE THE TECHNICAL ADVISORY COMMITTEE MEETING MINUTES OF JULY 12, 2016

The motion was made by Mr. Trudell, supported by Mr. Acker, to approve the Policy Committee meeting minutes of July 21, 2016 and to receive the Technical Advisory Committee meeting minutes of July 12, 2016. The motion carried unanimously.

ITEM 5 AGENCY STATUS REPORTS

Project status updates were reviewed by the City of Jackson, Jackson Area Transportation Authority, Jackson County Department of Transportation, Michigan Department of Transportation, and Jackson County Airport – Reynolds Field. Comments were as follows:

<u>City of Jackson</u> – The 2012 Trail St. project is now being cancelled due to litigation, and will be removed from the project list. Wisner St. project is complete, except portions of sidewalk that need to be completed after the PAKA lift station upgrade. Mr. Jancek requested a check of possible erosion problems. Lansing/Ganson signal project is complete. The Mechanic St. reconstruction project is underway and should be complete in mid-October. The Kibby Rd. project will be amended based on ongoing design.

<u>Jackson Area Transportation Authority</u> – Transit Center refurbishment is now complete and requested to be closed out. The rest of the projects included in the progress report are on schedule.

<u>Jackson County DOT</u> – Fifth Street project is now removing old curbing. W. Michigan Ave. bridge is currently being discussed with MDOT Rail and Amtrak. 2017 projects may need to be designed and managed by consultants due to staffing changes. Mr. Jancek asked about Blackman Rd. Rail inspections, and Ms. Kline said she would send information about MDOT rail representatives to the Board. Status reports were requested about the MDOT high speed rail upgrades in the city, but could only be provided by MDOT rail. Mr. Jancek asked about rail ownership, and Ms. Kline recommended the MDOT rail website.

MDOT – Mr. Gulock presented several MDOT projects that have been updated with work start dates, which has been included in the packet. Mr. Grazioli stated that there is a Transportation Summit in Blackman Township on November 2nd, 2016 at 9:00 AM. Mr. Overton raised concerns about emergency vehicles in Jackson being able to move around the city. Ms. Kline recommended contacting MDOT rail. Mr. Acker asked about the railroad project in Parma, Ms. Kline stated that JCDOT owns the project. Concerns were raised about ROW acquisition for the two-way conversion in Jackson.

<u>Jackson County Airport</u> – Mr. Feldvary informed the committee that landfill removal is complete, backfill is ongoing. Airport Rd. will be shut down in two weeks, for about four weeks. Fencing and fiber optic upgrades will be complete at the end of September. In September the new runway will open. Mr. Jancek asked where trucks would go for east end construction, currently unknown. Mr. Acker raised concerns about Leore Lane, which is being damaged by trucks.

ITEM 6 JACTS TRAVEL DEMAND MODEL UPDATE

Mr. Dawson explained the progress made on the base year socioeconomic data. The largest urban areas are still working on the employment counts, and Mr. Dowling stated that the city is about 25% complete. Mr. Dawson stated that any needed assistance will be provided by Region 2 Planning Commission and MDOT.

Ms. Torres asked if Region 2 Planning Commission is satisfied with the agreement, and Mr. Duke stated that it had been reviewed and found to be appropriate. Mr. Rand made a motion to approve the Memorandum of Understanding as presented, supported by Ms. Kline. The motion passed unanimously.

ITEM 8 FEDERAL HIGHWAY ADMINISTRATION (FHWA) APPROVAL OF THE JACTS PROPOSED CHANGES TO THE NATIONAL HIGHWAY SYSTEM

FY 2016

I-94 (OV Parma Rd, UN Gibbs Rd, OV Blackman Rd.) - Shallow and deep concrete overlays, full depth deck patches, concrete T-beam repairs, substructure repairs, bridge railing repairs, approach work, partial painting, thrie beam railing retrofit, concrete surface coating and traffic control. Project is underway. Single lane closures EB and WB until project completion mid-November.

I-94 (M-99, Michigan Ave, EB & WB over Concord Road, Dearing Rd, Sandstone Rd, Airport Rd) - Deck patching, joint replacement, epoxy overlay, partial paint, steel and concrete beam repairs, steel beam high load hit repairs, substructure repairs, approach work, barrier rail patching and maintaining traffic. Project is underway. Single lane closures EB and WB until project completion mid-November.

M-50 (Ganson to North and Michigan to Wildwood) – Full pavement reconstruction with drainage and other improvements. Ganson to North portion underway with through traffic detour. Project completed.

Lansing Ave over I-94-Bridge repair due to a high load hit last fall. Project is a partial deck replacement and beam repairs. Lansing avenue open to traffic, minor repair work remains.

M-60 (EB & WB OV I-94), (PE, SUB & ROW) – Bridge Replacement

Project scope is under development.

US-127 at Floyd - Offset SB Rt. Turn Lane & Overhead Flashing Signal

Project in design, all "M" funds. Anticipated July letting. Project under contract, construction this fall.

M-50 at Murray Rd. - Tree Removal & HMA Shoulder Addition.

Tree removal complete. Shoulder design underway, all "M" funds. Anticipated July letting. Project expanded to include all shoulders between US-127 and Rives Junction. Work scheduled to begin in October.

M-50 (US-127 to Napoleon Rd.) – Two course mill & resurface. August 2016 letting, 2017 construction. Project being constructed.

FY 2017

I-94 BL/W. Michigan Ave. (Brown St. to Washington / Louis Glick) – Full concrete pavement roadway reconstruction with water main, lighting and sidewalk replacement. Also includes City of Jackson initiated two-way conversion of Louis Glick Hwy. and Washington. Continuing to work on plan development. Right-of-Way acquisition is underway.

M-50 (**Rives Junction to Pope Church Road**) – Micro-surface of existing roadway pavement. Design work to begin later this year.

I-94 BL (Cooper Street to Dwight Street) – Single course mill and resurfacing with ADA sidewalk ramp improvements. Design work to begin later this year.

M-106 (Bunker Hill to East of Sayers Road) – Single course mill and resurfacing. Design work to begin later this year.

M-50/US-127 BR (North Street to Boardman) – Longitudinal joint repair with asphalt mastic and micro-surface materials. Design work to begin later this year.

I-94 (M-60 to Calhoun County Line) – Concrete patching. Design work to begin later this year.

US-127 (**Henry Rd. to M-36**) – Single course mill and resurfacing. Design by the Lansing TSC. Project will probably include pavement enhancement test section.

I have met with township, city, and village officials to verify this information at the local level. The next step in this process is approval of the information included with this memorandum, followed by estimation of the future year (2045) socioeconomic data that will also need to be approved.

If you would like to see a more detailed map and spreadsheet of the Transportation Analysis Zones (TAZs) for a particular jurisdiction (township, village, or city), I have them available.

During the design phase of Kibby Road we determined it was better to reconstruct the pavement on the southerly side of the boulevard rather than have one lane on each side of the boulevard. To accomplish this, we plan to install a roundabout at Kibby and Denton, realign Denton about 740' feet west of Kibby and install a non-motorized path from the City limits to Denton. The City is requesting that the revised project description for Kibby Road be approved. There is no change in the funding.
