## ITEM 3 ELECTION OF 2020 OFFICERS

## ITEM 4 APPROVE MINUTES OF THE POLICY COMMITTEE MEETING OF NOVEMBER 21, 2019 AND RECEIVE THE TECHNICAL ADVISORY COMMITTEE MINUTES OF NOVEMBER 20, 2019

## ITEM 5 AGENCY STATUS REPORTS

Project status updates were presented by the City of Jackson, Jackson County Department of Transportation, the Jackson Area Transportation Authority, Michigan Department of Transportation, and Jackson County Airport-Reynolds Field. The following project details were provided:

- <u>City of Jackson</u> Electricians are working to install street lights along the Greenwood/Jackson Street project.
- <u>Jackson Area Transportation Authority</u> The agency has applied for a grant to begin the Rides to Wellness program. The project has been a success in Flint. MDOT is providing the necessary financial match.
- <u>Jackson County Department of Transportation</u> The McDevitt Road project is underway. The plans for Phase 1 are under review. Phase 2 will be reviewed at the end of this month. Phases 1 and 2 will be completed this year. Phase 3 is a non-motorized path and an upgrade of traffic signals at Hague Avenue. The completion of phase 3 has yet to be determined.
- <u>Michigan Department of Transportation</u> Weather permitting, work will continue on I-94 this winter. The Grand River bridge work should be completed by mid-summer. Work will start on reconstructing the M-60 interchange in March. There is a public meeting to review the West Avenue interchange, Elm Road interchange, Lansing Avenue bridge projects on April 7<sup>th</sup>. A public information meeting to review the railroad bridge replacements at both Mechanic and Jackson Streets is scheduled for February 26<sup>th</sup> at the new Christoff's show room.
- <u>Jackson County Airport Reynolds Field</u> The airport has more operations (landings, takeoffs, etc.) than the commercial airports in Flint and Lansing. The terminal apron project will be completed by the end of this summer.

## ITEM 7 CITY OF JACKSON / JACKSON COUNTY NON-MOTORIZED PLAN UPDATE

Ms. DeOliveira reported that the consultant team is working on completing a final draft of the planning document. The Steering Committee met in December to review public comments. Ms. DeOliveira noted that she will be talking with the consultants later this month about stakeholder and public participation opportunities to review the final draft plan. The project will be completed in early 2020.

## ITEM 8 JACKSON COUNTY 2018/2019 PASER RATINGS

Ms. DeOliveira presented the Jackson County 2018/2019 PASER ratings. The percentage of roads in good condition continues to decline. However, this may change in next year's report, as the condition of some of the federal-aid eligible roads will improve because of the road millages that many of the townships have passed to repave their roads. Additionally, the rating of the roads took place in June this year, at the beginning of the construction season, unlike previous years, where the roads were rated in September or October, at the end of the construction season. This meant that any roads improved (resurfaced, repaved, reconstructed, etc.) during the 2019 construction season were not in this year's report, but will appear in next year's report.

## ITEM 2 PUBLIC COMMENT

No public comments were received.

## ITEM 3 ELECTION OF 2020 OFFICERS

## ITEM 4 APPROVE MINUTES OF THE TECHNICAL ADVISORY COMMITTEE MEETING OF NOVEMBER 20, 2019 AND RECEIVE THE POLICY COMMITTEE MINUTES OF NOVEMBER 21, 2019

A motion was made by Ms. Guerriero, supported by Mr. Franklin, to approve the Technical Advisory Committee meeting minutes of November 20, 2019, and receive the Policy Committee meeting minutes of November 21, 2019 as presented. The motion carried unanimously.

## ITEM 5 AGENCY STATUS REPORTS

Project status updates were presented by the City of Jackson, Jackson County Department of Transportation, the Jackson Area Transportation Authority, Michigan Department of Transportation, and the Enterprise Group. The following project details were provided:

- <u>City of Jackson</u> The City is working to repair the recently installed street lights that are not working along the Greenwood/Jackson Street project.
- <u>Jackson Area Transportation Authority</u> A new Gillig bus replacement will be delivered by the end of January. Two medium duty vans will be delivered by June.
- Jackson County Department of Transportation Work continues on Moon Lake Road bridge
  project this spring with the painting of the faux rocks on the bridge. JCDOT is waiting on a
  permit from Amtrak to start work on the Michigan Avenue bridge in Parma. The McDevitt
  Road project is underway. The plans for Phase 1 are under review. The limits for Phase 1 are
  from Draper Road east to Oak Lane Road. Plans for Phase 2 will be reviewed at the end of
  the month. Phase 2 runs from Francis Street to Draper Road. Phases 1 and 2 will be
  completed this year. Phase 3 is a non-motorized path and an upgrade of the traffic signal at
  Hague Avenue. The completion of phase 3 is still to be determined.
- <u>Michigan Department of Transportation</u> Weather permitting, work is continuing during the winter on I-94. The Grand River bridge work should be completed in mid-summer. Work will start on the M-60 interchange reconstruction in March.
- <u>Enterprise Group</u> Ms. Guerriero reported that she will be retiring by the end of March, and that this is her last JACTS Technical Committee meeting. Members of the Committee thanked her for her years of service. It was also reported that there is potential EDA grant funding to implement the recommendations from the County Farm Road Feasibility Study and construct the entrance road to the new Jackson Technology Park North.

Project Steering Committee members from JCDOT and MDOT asked for draft maps to review before the final draft plan is released to the public.

## ITEM 8 JACKSON COUNTY 2018/2019 PASER RATINGS

Ms. DeOliveira presented the Jackson County 2018/2019 PASER ratings. The percentage of the number of roads in good condition continues to decline. However, this may change in next year's report, as the condition of some of the federal-aid eligible roads will improve as a result of road millages that many of the townships recently approved. The rating of the roads took place in June 2019, at the beginning of the construction season, unlike previous years, where the roads were rated in September or October, at the end of the construction season. This meant that any roads improved (resurfaced, repaved, reconstructed, etc.) this past construction season were not captured in this year's report, but will appear in next year's report. JCDOT noted that they would like to continue rating roads at the beginning of the season. They also offered to rate the City of Jackson federal-aid eligible roads, if the City was interested.

## ITEM 9 OTHER BUSINESS

Mr. Franklin noted that Mr. Mark Kloha will be the new MDOT Statewide Planning Program Manager for the Jackson MPO. Mr. Kloha has 20 years of experience at MDOT, and has previously worked with other MPOs. The committee welcomed Mr. Kloha.

## <u>2019</u>

<u>Greenwood/Jackson Streets: Morrell to Franklin (Urban)</u> – Reconstruct roadway. HRC is the City's consultant on this project. The Project was let by MDOT on June 7 with Bailey Excavating as the low bidder. The roadwork is ready for paving, however, the weather is not cooperating. The plan is to fill the road base with mill tailings to provide a drivable surface for the winter and continue in the spring when the weather is suitable for paving. The signal work will not be finished until 2020.

## <u>2020</u>

<u>Martin Luther King Jr Blvd: Morrell to Mason (Urban)</u> – Reconstruct roadway. HRC is the City's consultant on this project. **Plans were submitted to MDOT and told we will be in the April, 2020 MDOT Letting.** 

## <u>2021</u>

<u>Morrell Street: Greenwood to Francis (Urban)</u> – Reconstruct pavement with curb repairs. Seven Proposals were received from consultants in January, 2020 with review by the City underway.

<u>Steward Street: RR to Ganson (Urban)</u> – Mill and asphalt resurface with curb repairs and signal reconstruction at Ganson. Seven Proposals were received from consultants in January, 2020 with review by the City underway.

## FY2019/FY2020

- 1. Vehicle Procurements
  - a. (4) Medium duty vans JATA is evaluating the first two vehicles and will begin the procurement process for the second two later in 2020.
    - i. We have ordered 2 additional Medium duty vans from Hoekstra which are similar to the ones we order back in May of last year. We just had some seating configuration changes.
  - b. (1) The 35-foot bus, manufactured by Gillig, has been delivered and is in the process of being prepared for service.

## 2. Bus & Bus Components

- a. Replace radio system and bus radios Project will begin sometime Spring 2020.
  - i. We received the approval from the state of Michigan regarding infrastructure requirements. We are currently waiting for approval from the 9-1-1 board of advisors to determine any yearly costs they will pass down to us as part of their yearly maintenance fees.

## 3. Facility Upgrades

- a. Admin office rehab and update has been put on hold.
- b. Surveillance upgrades (cameras, gates, etc..)
  - i. The Admin office rehab has been delayed until the HVAC system has been completed.
  - ii. The surveillance upgrades are slated to start in the middle of FY2020.
- 4. Grants
  - We are anticipating hearing about grant awards for DOT in regards to the Mobility for All Pilot program by the middle of the Spring 2020.

## Federal Funds Obligated in Fiscal Year 2019

As the state-designated Metropolitan Planning Organization for the Jackson urbanized area, the Region 2 Planning Commission, is responsible for developing and managing a 20-year Long Range Transportation Plan and a short-term, 4-year Transportation Improvement Program (TIP). The current edition of the TIP includes a listing of the approved road, highway, bridge, transit, and non-motorized projects programmed to receive federal and/or state funds in Jackson County during the 2020-2023 Fiscal Years.

The Federal legislation that was adopted in December 2015, continues through fiscal year 2020, Fixing American's Surface Transportation Act (FAST Act), continues the requirement of past legislation that "an Annual Listing of projects, for which federal funds have been obligated in the preceding year shall be published or otherwise made available by the metropolitan planning organization for public review. The listing shall be consistent with the categories identified in the Transportation Improvement Program."

In response to the above directive, the R2PC is providing a listing of all the projects in Jackson County "obligated" during FY 2019 (October 1, 2018 - September 30, 2019). The Federal Highway Administration (FHWA) defines obligated as the federal government's legal commitment to reimburse the implementing agency for the federal share of a project's eligible costs. Although not all obligated projects were initiated or completed during this fiscal year, they have been approved by the FHWA for reimbursement in FY 2019. Some projects actually constructed in FY 2019 were obligated in previous fiscal years and will not appear on this listing.

#### Speed management

Intersection speed management is possible using a range of treatments from ROW clarification to vertical deflection. The 2016 FHWA document Achieving Multimodal Networks: Applying Design Flexibility and Reducing Conflicts' provides important guidance toward applying speed management principles. The guide indicates that raised intersections and raised crosswalks can be used on arterial streets. Using this guidance and associated design principles, treatments that minimize crash risk for bicyclists may also improve safety for motorists.

Implementing vertical deflection with a raised bicycle crossing is one method to manage vehicle speeds. The raised crossing requires motorists to "ramp up" to the sidepath. Exhibit 6 illustrates a raised crossing of a bikeway at a side street. The vertical rise of the crossing can be constructed to attain a desired vehicle speed. Lower motor vehicle speeds increase the likelihood that a motorist will yield to a bicyclist in the crossing.

At driveways, 5 mph may be an appropriate speed management target. At unsignalized intersections, 10-15 mph may be more appropriate to balance traffic flow while maintaining sidepath user safety. At signalized intersections, vertical deflection would typically be implemented across a low-volume minor approach or driveway. The prevailing motor vehicle speeds approaching the crossing should be considered in the construction of a raised crossing.

Crash Trend #4: Bicyclists riding through signalized intersections have a higher risk than at intersections with other types of traffic control



Intersection crash statistics illustrate that 51 percent of sidepath/sidewalk bicycle crashes occur at signalized intersections. Of the 51 percent of crashes, 61 percent involve right-turning vehicles and 15 percent involve left-turning vehicles.

By comparison, 31 percent and 10 percent of all intersection-related sidepath/sidewalk bicycle crashes occur at unsignalized intersections and driveways, respectively.

In most cases, signalized intersections can be assumed to have greater traffic volumes for all modes than unsignalized intersections, based on the necessity of the traffic signal. Higher traffic volumes at signalized intersections – the greater exposure inherent in these contexts – can increase the crash risk between a bicycle and motor vehicle.

Horizontal treatments can also be used to manage motor vehicle speeds. In the safety analysis of sidepaths/sidewalks, many of the recorded crashes occurred between bicyclists and turning motor vehicles. One approach to mitigating these conflicts is to decrease curb radii, which are often designed to accommodate heavy vehicles. In some situations, heavy vehicle traffic volumes may be low enough that the need for large curb radii is reduced. In lieu of reconstructing intersection corners, smaller radii may be created using cost-effective plastic delineators or retrofitted truck aprons. Exhibit 7 illustrates a truck apron that discourages high-speed turns for passenger cars but still allows truck movements.
