# ITEM 3 APPROVE MINUTES OF THE TECHNICAL ADVISORY COMMITTEE MEETING OF JANUARY 15, 2020 AND RECEIVE THE POLICY COMMITTEE MINUTES OF JANUARY 16, 2020

#### ITEM 4 AGENCY STATUS REPORTS

Project status updates were presented by Jackson County Department of Transportation, the Michigan Department of Transportation, and the Enterprise Group. The following project details were provided:

- <u>Jackson County Department of Transportation</u> The Michigan Avenue Bridge project in Parma may not start in February. The County is waiting hear from Amtrak to receive the project's construction phase agreement.
- <u>Michigan Department of Transportation</u> The 2020 construction projects are moving forward. The I-94/US-127 interchange improvement, I-94 to Calhoun County Line, improvements to the Elm Street and Lansing Street bridges and interchanges projects are moving on an accelerated timeline due to being a part of the Michigan Rebuild Program supported by the Governor.
- <u>Enterprise Group</u> JCDOT is working with the Enterprise Group to design aspects of the County Farm Road project. The project calls for sidewalks, shoulders, modernization of traffic signals and better access to the industrial park. Construction on the project may begin in July.

#### ITEM 5 JACTS FY 2019 LIST OF FEDERALLY-OBLIGATED PROJECTS

Mr. Duke reported that the JACTS FY 2019 Obligation Report is now available online. Each year the federal government requires the Jackson MPO to prepare a list of road construction and transit projects that received federal funding.

#### ITEM 4 AGENCY STATUS REPORTS

Project status updates were presented by the City of Jackson, Jackson County Department of Transportation, the Jackson Area Transportation Authority, and the Michigan Department of Transportation. The following project details were provided:

- <u>City of Jackson</u> The traffic signal mast arms are being installed within the Greenwood / Jackson Street project.
- Jackson Area Transportation Authority A summary of the Rides to Wellness program that JATA is considering was provided. JATA is investigating the feasibility of a new program that would provide comprehensive, non-emergency transportation that includes door-to-door service and same day service to riders going to medical or other health and wellness related appointments. The program would be similar to a successful program in Flint. A request for a "Mobility for All" pilot program grant through the Federal Department of Transportation has been submitted. Funding sources may include federal, state, insurance agencies, and other local sources. More information will be provided as it becomes available.
- Jackson County Department of Transportation The construction phase agreements came in yesterday from Amtrak for the Michigan Avenue Bridge project in Parma. Work on the project should begin in April. The Laurence Avenue project will begin in Spring. All of the 2020 construction projects have their GI's scheduled.
- <u>Michigan Department of Transportation</u> Work on the I-94 Grand River bridge substructure continues. Beams are being set in March that would allow for a possible summer completion date.

#### <u>2019</u>

<u>Greenwood/Jackson Streets: Morrell to Franklin (Urban)</u> – Reconstruct roadway. HRC is the City's consultant on this project. The Project was let by MDOT on June 7 with Bailey Excavating as the low bidder. The roadwork is ready for paving, however, the weather is not cooperating. The plan is to fill the road base with mill tailings to provide a drivable surface for the winter and continue in the spring when the weather is suitable for paving. **The signal work is complete.** 

#### <u>2020</u>

<u>Martin Luther King Jr Blvd: Morrell to Mason (Urban)</u> – Reconstruct roadway. HRC is the City's consultant on this project. **Plans were submitted to MDOT and we will be in the May 1, 2020 MDOT Letting.** 

#### <u>2021</u>

<u>Morrell Street: Greenwood to Francis (Urban)</u> – Reconstruct pavement with curb repairs. **Recommendation for award is going to City Council on March 17, 2020.** 

<u>Steward Street: RR to Ganson (Urban)</u> – Mill and asphalt resurface with curb repairs and signal reconstruction at Ganson. **Recommendation for award is going to City Council on March 17, 2020.**

#### February 2020

#### FY2019/FY2020

- 1. Vehicle Procurements
  - a. JATA has ordered 2 additional Medium duty vans from Hoekstra which are similar to the ones we order back in May of 2019. We just had some seating configuration changes.
  - b. (1) The 35-foot bus, manufactured by Gillig, has been delivered and is in the process of being prepared for service.
- 2. Bus & Bus Components
  - a. Replace radio system and bus radios Project will begin sometime Spring 2020.
    - i. JATA received the approval from the state of Michigan regarding infrastructure requirements. We are currently waiting for approval from the 9-1-1 board of advisors to determine any yearly costs they will pass down to us as part of their yearly maintenance fees.
- 3. Facility Upgrades
  - a. Admin office rehab and update has been put on hold.
  - b. Surveillance upgrades (cameras, gates, etc..)
    - i. The Admin office rehab has been delayed until the HVAC system has been completed.
    - ii. The surveillance upgrades are slated to start in the middle of FY2020.
- 4. Grants
  - a. JATA is anticipating hearing about grant awards for DOT in regards to the Mobility for All Pilot program by the middle of the Spring 2020.
  - b. JATA is applying for the 5339(b) Bus and Bus Facilities grant. We are asking to replace two
     (2) 35-foot buses, five (5) bus hoists, and both of our parking lots one at the administrative building and the other at the transfer center. Announcement for the grant award recepients will be sometime in the Summer of 2020.

<u>FY 2020</u>

#### **Construction:**

**I-94** (**M-60 to Sargent**) – Pavement removal and aggregate base placement is occurring on WB I-94 between Lansing and Elm. Bridge construction occurring on WB I-94 over the Grand River and RR. Beams will be set near the first two weeks of April.

M-60 bridge over I-94 – Bridge replacement. Work will begin in mid-March.

US-127 (Floyd to I-94) – Concrete pavement repairs from Floyd to I-94. Work will begin near late April.

**Various traffic signal replacement** – Signal modernization project. Poles installed at M-106/North intersection. Waiting on mast arms.

**M-50** (**Brooklyn village limits**) – Preventative maintenance resurfacing and sidewalk ramps. Work will begin near late July.
