# ITEM 4 AGENCY STATUS REPORTS

Project status updates were presented by City of Jackson, Jackson County Department of Transportation, Jackson Area Transportation Authority, and the Michigan Department of Transportation. The following project details were provided:

- <u>City of Jackson</u> The Greenwood/Jackson traffic signal is complete. The change order for the project has gone to MDOT to have concrete installed around the traffic circle instead of asphalt. The Martin Luther King Jr. Boulevard project is scheduled to be let in May. The FY2021 Morrell Street and Steward Street projects contracts with Hubble Roth Clark were approved by City Council.
- <u>Jackson County Department of Transportation</u> The Preventative Maintenance 2019 project will start on April 13. Paving will occur in the northwest quadrant of the county. Surveying for the Michigan Avenue Bridge project in Parma will start in mid-April. King Road project will be in the June 5<sup>th</sup> letting.
- <u>Jackson Area Transportation Authority</u> All of their services are still running, including the paratransit service. Onboarding and off boarding of the busses are being done only through the rear doors. Fares are also not being collected at this time. They are also trying to enforce 6 feet of social distancing. There are no weekend or evening services being run at this time.
- <u>Michigan Department of Transportation</u> The beams are being set for the bridge that spans the railroad and the Grand River for the I-94 project. The public meeting that was scheduled for April will be rescheduled as a virtual meeting/webinar. Direct mailings will be sent to households that live near the project corridor. More details will follow. The contractor for the M-60 over I-94 project has decided to shut down for two weeks in regards to the COVID-19 pandemic. MDOT is maintaining communication with the contractor on this matter.

# ITEM 4 AGENCY STATUS REPORTS

Project status updates were presented by the City of Jackson, the Jackson Area Transportation Authority, Jackson County Department of Transportation, the Michigan Department of Transportation and Jackson County Airport-Reynolds Field. The following project details were provided:

- <u>City of Jackson</u> The Greenwood/Jackson traffic signal is complete. The change order for the project has been sent to MDOT to have concrete installed around the traffic circle instead of asphalt to reduce long-term wear on the road. The Martin Luther King Jr. Boulevard project is scheduled to be let on May 1. The FY2021 Morrell Street and Steward Street projects contracts with Hubble Roth Clark were approved by City Council.
- <u>Jackson Area Transportation Authority</u> The new Gilig buses have arrived, and are being prepared to be put in use. They continue to pursue funding to replace other old buses.
- Jackson County Department of Transportation The Norvell Road project is tentatively
  expected to be completed in early June. The McDevitt Road Phase 1 project bids have been
  received, and work is scheduled to begin soon. The Preventative Maintenance 2019 project
  will start on April 13. Paving will occur in the northwest quadrant of the county. Surveying for
  the Michigan Avenue Bridge project in Parma will start in mid-April, and a detour will be set
  up to go around the project. King Road project will be in the June 5<sup>th</sup> letting.
- <u>Michigan Department of Transportation</u> The public meeting that was scheduled for April will be rescheduled as a virtual meeting. Direct mailings will be sent to households that live near the project corridor. More details will follow. The contractor for the M-60 over I-94 project has decided to shut down for two weeks in regards to the COVID-19 pandemic. MDOT is maintaining communication with the contractor on this matter.
- Jackson County Airport-Reynolds Field Flight activity is down due to the COVID-19
  pandemic. Colleges and university who use the airport for training have stopped. The airport
  remains open per FAA guidelines with measures in place to protect employees. The terminal
  apron reconstruction project pre-construction meeting is planned for May, with a project start
  day of May 20. The Airport Board is meeting via teleconference calls.

# <u>2019</u>

<u>Greenwood/Jackson Streets: Morrell to Franklin (Urban)</u> – Reconstruct roadway. HRC is the City's consultant on this project. Bailey Excavating is the contractor on this project. The roadwork modification is approved by MDOT and the contractor started May 6 to complete the project.</u>

#### <u>2020</u>

Martin Luther King Jr Blvd: Morrell to Mason (Urban) – Reconstruct roadway. HRC is the City's consultant on this project. The project was let by MDOT with Bailey Excavating as the low bidder. Construction is scheduled to start in early June.

#### <u>2021</u>

- Morrell Street: Greenwood to Francis (Urban) Reconstruct pavement with curb repairs. HRC is the City's consultant on this project.
- <u>Steward Street: RR to Ganson (Urban)</u> Mill and asphalt resurface with curb repairs and signal reconstruction at Ganson. **HRC is the City's consultant on this project.**
- <u>Bridge CPM (BHT) Denton, Mechanic, North and Trail</u> Rehabilitation on the four bridges. Great Lakes Engineering is the City's consultant on this project.
- <u>Elmdale Trail: Hickory to South St (SR2S)</u> Reconstruction of the existing path to a 10' wide concrete non-motorized path. **Rowe Professional Services is the City's consultant on this project.**
- <u>Wisner St Traffic Signals (HSIP) Ganson, North and Argyle</u> Replacement of the existing traffic signals at these three intersections with mast arm signals. **HRC is the City's consultant on this project.**

# <u>2022</u>

<u>E. High Street Bridge over the Grand River</u> - Replacement of the existing bridge superstructure. **HRC is the City's consultant on this project.**

# May 2020

# 1. Vehicle Procurements

- a. (4) Medium duty vans JATA has evaluated the vans from the previous procurement.
  - i. We have ordered (2) additional medium duty vans from Hoekstra which are similar to the (2) ordered back in May of FY2019. There were seating configuration changes for this build.
- b. The new 35-foot bus, manufactured by Gillig, was put into service on April 6<sup>th</sup> of 2020.
- 2. Bus & Bus Components
  - a. Replace radio system and bus radios –The RFP for this procurement is currently under development.
    - i. JATA is still waiting for confirmation from the county's attorney on the yearly maintenance fees associated with being on the county's towers. At the last 911 Advisory meeting on May 4th the committee was estimating those fees to be approximately \$85 to \$95 per radio.

# 3. Facility Upgrades

- a. Surveillance upgrades (cameras, fencing and gates)
  - i. The security camera upgrades are set to begin in the 4<sup>th</sup> quarter of FY2020.
  - ii. The fences and gates are set to begin in the 4<sup>th</sup> quarter of FY2020.

#### 4. Grants

- a. JATA is anticipating hearing about grant awards from the DOT regarding the Mobility for All Pilot program sometime in the summer of FY2020. Due to Covid-19 there has been a delay in the announcement of the awards.
- b. JATA is working on two more grants which are both due May 18<sup>th</sup> FY2020.



#### FY 2020

#### **Construction:**

**I-94** (M-60 to Sargent) – Milling and pavement repairs are occurring prior to asphalt paving on I-94 between M-60 & Airport Road and also between US-127 south and Sargent Road. Concrete paving will begin soon underneath Cooper Street on WB I-94. Rebar is being placed on the WB I-94 bridge over the Grand River to prepare for a bridge deck pour.

**M-60 bridge over I-94** – The existing SB/WB M-60 bridge over I-94 has been demolished and work has begun on the new foundation. Both directions of M-60 are being maintained on the NB/EB structure using crossovers.

**US-127** (Floyd to I-94) – Concrete pavement repairs from Floyd to I-94. Work will begin later in the spring or early summer.

**Various traffic signal replacement** – Signal modernization project. Poles installed at M-106/North intersection. Waiting on mast arms.

**M-50** (**Brooklyn village limits**) – Preventative maintenance resurfacing and sidewalk ramps. Work will begin near late July.

**US-127 near Hart Road** – Install camera for overweight vehicle enforcement. Work will begin in midsummer.

Various routes – pavement markings

Various routes – crack sealing

I-94 (countywide) – Install cameras and permanent message boards (late 2020 construction).

#### Design:

M-106 and I-94BL – Non-freeway signing upgrade (2021 construction)

**Railroad bridges over Jackson Street and Mechanic Street in downtown Jackson** – Bridge replacement (2021 construction).

**I-94 at Elm Road, Lansing Road and West Ave (US-127 west)** – Preparing Design/Build letting package (2021-2023 construction). Also includes resurfacing on US-127 (I-94 to Parnall)

US-127 (Henry to near Ingham Co Line) – state funds only, major resurfacing (future construction)

**I-94 from M-60 to Calhoun County line** – Reconstruction from M-60 to Michigan Ave, major rehabilitation from Michigan Ave to Calhoun County line – 2022-2023 construction.



JACTS Airport Update May 2020

- Terminal Apron project start date has been pushed back to June 15, 2020. Preconstruction meeting will be May 19<sup>th</sup>.
- JC-DOT started milling abandoned runway 06-24 pavement. Part of the pavement will remain to be used as a temporary taxiway for phase 1 of the terminal apron project. Once phase 1 is completed JC-DOT will remove the rest of the pavement except for 240 feet that will be used for future airport development.
