



## Subject: JCHMP Advisory Committee Recruitment

Jackson County wants to develop an up-to-date edition of the *Jackson County Hazard Mitigation Plan* (JCHMP). The effort will involve a countywide Risk/Vulnerability Assessment and an associated Mitigation Strategy. Completion and approval of the next JCHMP edition will allow the County to apply for grants to complete hazard mitigation projects, further increasing the County's ability to plan for and mitigate the effects of hazards.

The Region 2 Planning Commission will facilitate the planning process. An Advisory Committee, which includes the Office of Emergency Management (Jackson County Office of the Sheriff), will develop the next JCHMP edition. The OEM and R2PC identified you as a key stakeholder and a potential member of the Advisory Committee (see the attached roster). The Committee will meet five times throughout the remainder of 2020 and 2021 (see the proposed schedule below).
