#### 2021

<u>Steward Street: RR to Ganson (Urban)</u> – Mill and asphalt resurface with curb repairs and signal reconstruction at Ganson. HRC is the consultant on this project. Project was let by MDOT on June 7 with J Ranck as the low bidder. All surface and subsurface work is complete. Delivery of signal poles and mast arms is scheduled for mid-March to April.

<u>Wisner St Traffic Signals (HSIP) Ganson, North and Argyle</u> – Replacement of the existing traffic signals at these three intersections with mast arm signals. HRC is the consultant on this project. All surface and subsurface work is complete. Delivery of signal poles and mast arms is scheduled for April 2022.

#### 2022

E. High Street Bridge over the Grand River – Replacement of the existing bridge superstructure. HRC is the consultant on this project. Contractor is The Beaver Excavating Co. Preconstruction meeting was held March 7. Work to start mid May with steel beams scheduled to be delivered about July 5.

West Avenue Signals at Franklin, Washington and Morrell with Ganson and Elm Signal - Reconstruct Signals on West Ave at Franklin and Morrell with Signal at Ganson and Elm. HRC is the consultant on this project. Contractor is Wright Electric Co. City Council approved MDOT contract March 8. Construction contract to be awarded soon. Road work cannot start until the water main contract is finished.

Greenwood Ave: Fourth St to Morrell St with Greenwood/Fourth & Fourth/Prospect Signals
- Mill and HMA Resurface on Greenwood with signal replacements at the intersections.
HRC is the consultant on this project. Contractor is Michigan Paving and Materials Co.
City Council approved MDOT contract March 8. Construction contract to be awarded soon. Road work cannot start until after the Rose parade on June 5.

#### 2023

<u>Brown Street: Morrell to Michigan – Mill and HMA Relocate curb and construct non-motorized trail on east side.</u> City Council awarded the design contract to Spaulding DeDecker on March 8.

<u>Wildwood Avenue: West Ave to Steward</u> – Mill and HMA Resurface. City has sent out Request for Proposals to obtain consultant. **City Council awarded the design contract to Spaulding DeDecker on March 8.** 

<u>Crosswalk Enhancements at 5 Locations (HSIP)</u> – Sidewalk ramps, LED bordered signs, along non-motorized paths. HRC is the consultant on this project.

We would like to provide the following update regarding our projects that are on the Transportation Improvement Program (TIP) for FY 2021, 2022, and 2023.

#### FY 2021

#### JN 207171 McCain Road and Robinson Road

Work has been completed on the McCain Road portion of this project. Work will commence on Robinson Road and at the intersection of Robinson/McCain following the end of the 2021-22 school year.

#### JN 206636 Overlay Project, Territorial Road and Clark Lake Road All-Season Routes

Michigan Paving and Materials will construct this project during the 2022 construction season.

#### FY 2022

#### County Farm/Springport Corridor Improvements and Jackson Technology Park - North Construction

Comments for the draft final plans were received from the EDA in January, and final plans, specs, and estimates were submitted in late February. All easements were submitted to the Board for February approval. The Enterprise Group is working with the EDA on title clearance and a covenant for the new park, and the project will be let following completion of these tasks. Anticipated letting in March or April.

#### JN 210343 South Dearing Road and McCain Road Compact Roundabout

This project was moved to FY 2022 due to right of way procurement issues. JCDOT met with the property owners on the northwest corner on Friday, March 4<sup>th</sup>, 2022, to show them the fully developed "peanut roundabout" conceptual design. The peanut roundabout will stay completely inside the right of way next to their property. A maximum monetary offer was also given to them for acquisition of right of way for the original roundabout design. The original design is the preferred option due to the better geometrics of the roundabout. The residents have been given some time consider the offer and the alternatives that were presented to them.

#### JN To Be Determined - Holibaugh Road

A TIP amendment has been submitted to add this project to 2022. This proposed project uses a portion of the current funding from the JN 206637 Preventive Maintenance project. This project will place a preventive maintenance wedge and overlay on Holibaugh Road from the north Village of Springport limits to the Eaton/Jackson County line, a distance of 2.6 miles.

#### JN 206637 Preventive Maintenance

A TIP amendment has been submitted for this project to subtract the funding that was allocated to the Holibaugh Road project as well as add funding from the additional Federal funding that was recently received.

#### JN 207169 South Street Preventative Maintenance

The GI meeting took place in January. Project documents will be submitted for an anticipated May 2022 letting.

#### JN 209883 S. Jackson Bridge Replacement

Project documents have been submitted for a June or July 2022 letting. Awaiting NEPA approval so that project can go to letting. There are environmental restrictions on this project until June 30<sup>th</sup> that do not allow work in the water.

#### JN 210635 Mike Levine Lakelands Trail Extension

Project documents will be submitted for letting once ROW issues are resolved – negotiations with Consumers are ongoing due to the presence of contaminated materials in their proposed easement. JCDOT will have an update on this property in April, once the site has been tested.

#### JN 211703 Roundabout at Horton Road and Springbrook Road

Property line surveys have been requested from local survey firms. Developing environmental documents and beginning design for a Fall 2022 letting.

### JN 211779 Countywide Horizontal Curve Signing JN 211851 Countywide LED Stop Signs

NEPA documents have been submitted. GI Documents to be submitted within the next month. A TIP amendment is on this month's cycle to add funding to the project to offset the increased bid prices that have been seen with sign materials.

JN 211823 N. Concord Road Tree Removal JN 211852 Moscow Road Tree Removal JN 211853 Rives Junction Road Tree Removal

Documents were submitted in early March for a GI Meeting, with an anticipated July 2022 letting and Winter 2022 construction.

Developing environmental documents and beginning design for a Fall 2022 letting.

JN 211862 Page Avenue Road Safety Audit JN 211864 Spring Arbor Road Road Safety Audit

Due to Consultant availability, the Spring Arbor Road RSA will begin in late April 2022. The Page Avenue RSA will begin sometime in Spring 2022.

Documents were submitted in early February for a GI Meeting. Project documents were submitted for a June 22 letting, with construction taking place in Summer 2023.

#### PROJECT REPORT 2020-2023 TIP

#### **March 2022**

#### 1. Vehicle Procurements

a. We are beginning the process of replacing two (2) more of our Dodge Sprinters which are beyond their useful life benchmark (ULB). I have confirmed funding through our program manager at MDOT and we can begin the process of procuring the vehicles we need.

#### 2. Bus & Bus Components

a. We are currently working with the State of Michigan, through MDOT, to procure automated wheelchair securements. We were one of a few transit agencies in the state which were selected to be part of a grant to procure and demonstrate these securements in our vehicles. We have submitted our documentation to the state and are waiting on next step guidance in the process.

#### 3. Facility Upgrades

- a. We have upgraded two (2) outdated copy machines in our main offices with new multifunction printers (MFPs). During the procurement process, we received four (4) bids and the winning bid was a local company, located here in Jackson. These machines are said to be more energy efficient so we hope this will save us money in the long-term and we have also signed a maintenance agreement with this company as their option was the least expensive of the offerings.
- b. We have received initial site plans from the engineering and architectural firm, Fishbeck, who is currently working on plans for the concrete replacement project at the downtown Transfer Center. We had the opportunity to meet with Troy White and Chris Atkin from the City to ensure the site plans and drawings take into account city zoning compliance. With the information Fishbeck received, they are preparing the final drawings, statements of work, and construction estimates so we can go out to bid for the construction phase of the project.

#### 4. Grants

a. In October of last year, we applied for a competitive 5339(b) grant for the procurement of two (2) new Gillig city buses. The award for this grant is scheduled to be announced at the end of March.

#### **Construction:**

**I-94 & US-127** – Install cameras and/or permanent message boards near Airport Road, Parnall Road, Page Ave, I-94/US-127 south interchange, Hawkins Road, Whipple Road, and Grass Lake Scales. Message boards installed and working on communication connections.

**I-94 at Elm Road, Lansing Ave. and West Ave (US-127), also includes resurfacing on US-127 (I-94 to Parnall)** – Both directions of I-94 are on the new westbound roadway. Traffic will remain in this configuration through the winter, with all ramps open, except the northbound West Ave to WB I-94, which will remain closed thru the winter. Work continues near the Elm Road interchange, the Shirley Drive pond, and miscellaneous bridge work.

**US-127 bridges over M-50/Railroad (just north of McDevitt)** – Deck replacement and superstructure repairs. Work resumes the week of March 7<sup>th</sup>.

Railroad bridges over Jackson Street and Mechanic Street in downtown Jackson – Bridge replacements. Construction scheduled to begin on March 14, 2022 with Mechanic, Jackson, Detroit and Van Buren Streets being closed.

**I-94 from M-60 to Calhoun County line** – Reconstruction from M-60 to Michigan Ave, major rehabilitation from Michigan Ave to Calhoun County line – (2022-2024 construction). Project was let on February 18<sup>th</sup>.

#### Design:

M-106 and I-94BL – Non-freeway signing upgrade (late 2022 construction).

**I-94 Westbound from Mt. Hope Road to Washtenaw County line** – Capital preventative maintenance resurfacing (2023 construction)

M-50 from Valley Farm Road to Lincoln Road – Shoulder paving (2023 construction)

Cooper Street (M-106) bridge replacement in downtown Jackson south of train station – Bridge replacement (2024 Construction).

**US-127** (Henry to near Ingham Co Line) – state funds only, major resurfacing (future construction).
