<u>2021</u>

- <u>Steward Street: RR to Ganson (Urban)</u> Mill and asphalt resurface with curb repairs and signal reconstruction at Ganson. HRC is the consultant on this project. Project was let by MDOT on June 7 with J Ranck as the low bidder. All surface and subsurface work is complete. Delivery of signal poles and mast arms is scheduled for mid-May.
- <u>Wisner St Traffic Signals (HSIP) Ganson, North and Argyle</u> Replacement of the existing traffic signals at these three intersections with mast arm signals. HRC is the consultant on this project. All surface and subsurface work is complete. **Signal poles and mast arms were delivered and are being installed.**

<u>2022</u>

- E. High Street Bridge over the Grand River Replacement of the existing bridge superstructure. HRC is the consultant on this project. Contractor is The Beaver Excavating Co. Bridge demolition started on May 9th. Steel beam delivery is still scheduled for about July 5th.
- West Avenue Signals at Franklin, Washington and Morrell with Ganson and Elm Signal -Reconstruct Signals on West Ave at Franklin and Morrell with Signal at Ganson and Elm. HRC is the consultant on this project. Contractor is Wright Electric Co. Preconstruction meeting was held on April 5th. Road work cannot start until the water main contract is finished.
- <u>Greenwood Ave: Fourth St to Morrell St with Greenwood/Fourth & Fourth/Prospect Signals</u> - Mill and HMA Resurface on Greenwood with signal replacements at the intersections. HRC is the consultant on this project. Contractor is Michigan Paving and Materials Co. Preconstruction meeting was held on April 5th. Road work cannot start until after the Memorial Day parade on May 31st.

<u>2023</u>

- <u>Brown Street: Morrell to Michigan Mill and HMA Relocate curb and construct non-motorized</u> trail on east side. Spaulding DeDecker is the consultant on this project.
- <u>Wildwood Avenue: West Ave to Steward</u> Mill and HMA Resurface. City has sent out Request for Proposals to obtain consultant. Spaulding DeDecker is the consultant on this project.
- <u>Crosswalk Enhancements at 5 Locations (HSIP)</u> Sidewalk ramps, LED bordered signs, along non-motorized paths. HRC is the consultant on this project.

RE: May JACTS Update

We would like to provide the following update regarding our projects that are on the Transportation Improvement Program (TIP) for FY 2021, 2022, and 2023.

Fiscal Year 2021

STUL (Urban) Federal Aid Projects

JN 207171 McCain Road and Robinson Road

Work has been completed on the McCain Road portion of this project. Work will commence on Robinson Road and at the intersection of Robinson/McCain following the end of the 2021-22 school year.

STP Local (Rural) Federal Aid Project

JN 206636 Overlay Project, Territorial Road and Clark Lake Road All-Season Routes

The project will began May 2nd with cross culvert replacements. Paving of the wedge/leveling course is scheduled to begin the week of May 12th. Completion is scheduled for early July.

Fiscal Year 2022

STUL (Urban) Federal Aid Projects

JN 207169 South Street Preventative Maintenance

Project will be in a June 2022 letting with a November 2022 completion date.

STP Local (Rural) Federal Aid Projects

JN 215587 – Holibaugh Road

This project will place a preventive maintenance wedge and overlay on Holibaugh Road from the north Village of Springport limits to the Eaton/Jackson County line, a distance of 2.6 miles. Environmental documents have been submitted.

JN TBD – Pavement Markings

Project has been abandoned. Funds have been moved to other FY 2022 safety projects. JCDOT will perform pavement marking work with local funds using a current competitively bid pavement marking contract.

JN 206637 – Preventive Maintenance (Various Roads)

Project has been abandoned. Funds have been moved to other FY 2022 safety projects.

U.S. Economic Development Administration (EDA) Grant Project

County Farm/Springport Corridor Improvements and Jackson Technology Park – North Construction The Enterprise Group and JCDOT is waiting on title clearance from the EDA and permission to go to a bid letting. Anticipated letting in May/June.

MDOT Local Bridge Program

JN 209883 S. Jackson Bridge Replacement

Project documents have been submitted for a summer letting date. This project completion date has been extended until next year due to bridge construction cost pressures. The bridge project itself will still have stipulations on the amount of time that it can be closed for construction. This project will replace the existing bridge with a precast box culvert.

Transportation Alternatives Program (TAP) Grant – Shared-use Pathway Project

JN 210635 Mike Levine Lakelands Trail Extension

The Michigan Department of Environment, Great Lakes, and Energy is requiring hazardous material testing through the Consumers easement. Also working with a property owner to obtain an easement for the path along Lansing Avenue. Once these issues are resolved, a letting date can be determined.

HRRR & HSIP Funding – MDOT Safety Grant Projects

JN 210343 Compact Roundabout at South Dearing Road and McCain Road

This project was moved to FY 2022 due to right of way procurement issues. JCDOT met with the property owners in March and presented a maximum offer from the county. The offer was not accepted, and JCDOT is moving forward with the alternate design of a "peanut shaped" roundabout.

JN 211703 Compact Roundabout at Horton Road and Springbrook Road

Environmental documents have been submitted. Conceptual plans are taking shape. Project is expected to be in a Fall 2022 letting with construction in Summer 2023.

JN 211855 Compact Roundabout at Springport Road and Rives Junction Road

Environmental documents have been submitted. Conceptual plans are taking shape. Project is expected to be in a Fall 2022 letting with construction in Summer 2023.

JN 211779 Countywide Horizontal Curve Signing (West and Northeast) – CONSTRUCTION JN 211851 Countywide LED Stop Signs

NEPA documents have been approved. GI Documents have been submitted and a GI meeting has been requested.

JN 211779 Countywide Horizontal Curve Signing – DESIGN

JCDOT will obtain vendor bids for this project.

JN 211823 N. Concord Road Tree Removal

JN 211852 Moscow Road Tree Removal

JN 211853 Rives Junction Road Tree Removal

Documents were submitted in early March for a GI Meeting, with an anticipated July 2022 letting and Winter 2022 construction.

JN 211862 Page Avenue - Road Safety Audit JN 211864 Spring Arbor Road - Road Safety Audit

The Spring Arbor Road RSA meeting will be held May 11th. The Page Avenue RSA will begin sometime in Spring 2022.

JN 213736 Edgeline Pavement Markings

Project documents were submitted for a June letting, with construction taking place in Summer 2023.

JN 213875 N. Stony Lake Road, Seymour Road, and Race Road Tree Removal

JCDOT is developing environmental documents and is beginning design for a Summer 2022 letting.

JN 214064 Horton Road (Ferguson Road to Weatherwax Drive) Road Safety Audit JN 214065 Moscow Road Intersections Road Safety Audit

A request for proposals was released for the Horton Road/S. Jackson Road RSA in early March; due to a lack of responses, it will be re-released in May.

Fiscal Year 2023

HRRR & HSIP Funding – MDOT Safety Grant Projects

JN 213879 Dearing Road and Jefferson Tree Removal

JCDOT is developing environmental documents and is beginning design for a Summer 2023 letting.

JN 213984 Springport Road and Minard Road Compact Roundabout

JCDOT is developing environmental documents and is beginning design for a Summer 2023 letting.

JN 214462 Countywide Horizontal Curve Signing (Southeast)

JCDOT is developing environmental documents and is beginning design for a Summer 2023 letting.

JN 214463 Countywide LED Stop Signs

JCDOT is developing environmental documents and is beginning design for a Summer 2023 letting.

JN 214464 Countywide High Friction Surface Treatment and LED Stop Signs

JCDOT is developing environmental documents and is beginning design for a Summer 2023 letting.

JN 214664 Airport Road at Wayland Drive/Meijer Drive Signal Modernization

JCDOT is developing environmental documents and is beginning design for a Summer 2023 letting.

PROJECT REPORT 2020-2023 TIP

May 2022

- 1. Grants
 - a. We are continuing to seek out competitive grant opportunities to fund TIP approved projects.
 - b. We are in the process of completing our annual application for formula funding through the FTA.
- 2. Vehicle Procurements
 - a. We are still working with Gillig to get the requested pricing on options for the new bus we ordered such as, the driver barrier, installation of a bike rack, and the use of the Quantum automated wheelchair securement position instead of the traditional wheelchair restraints. Once we have that price quote, we will be able to process the change order for the bus we initially ordered and add the other two (2) buses to the order which we recently received the competitive funding for.
 - b. We submitted to Hoekstra an order for three (3) new Ford Transit vans. The current wait time for manufacture and delivery of the vehicles is approximately 6-8 months. These vehicles are being procured through a State of Michigan vehicle contract.
- 3. Bus & Bus Components
 - a. As we reported last month, we are currently working with the State of Michigan, through MDOT, to procure automated wheelchair securements. This project involves retrofitting six (6) of the city buses in our current active fleet with the new wheelchair securement positions as well as retrofitting the seating to be compatible with the new wheelchair positions. The vendor chosen for this procurement by MDOT is Q'Straint. On April 4th, we submitted the purchase order to get this project in motion. We are currently anticipating receiving the equipment by July 2022, however, the representative from Q'Straint stated he was going to attempt to get the necessary equipment for the retrofit to us prior to that.
- 4. Facility Upgrades
 - a. We have received the site plans for a final review from the engineering and architectural firm, Fishbeck, for the concrete replacement project at the downtown Transfer Center. Pending approval, we will be able to compose the request for proposal (RFP) and begin the procurement process for the construction phase of the


project. They are adding some additional design work in as the catch basins along the driveway are in ill repair and in need of rebuilding as well.

- b. We have published the RFP for the bus lift project in our maintenance facility. We anticipate awarding the project June 17, 2022, assuming we receive enough bids.
- c. The overhead doors for our maintenance and bus storage facilities are weathered, worn, and becoming cost prohibitive to maintain. I have been able to secure approval from the FTA to reallocate funds from older grants to finance a project to replace these doors throughout our facility. We are still waiting on MDOT to approve the updated project. Once that is completed, we will be able to start the procurement process.

Definitions

On Time Performance: For fixed route it is the % of vehicles that arrived at the downtown transfer center no more than one minute before or four minutes after the scheduled arrival time. For Reserve-A-Ride it is the % of vehicles that arrived at the designated pick-up location within the assigned 30 minute window. Excludes will calls and no-shows.


Revenue Hours: Time travelled while in service and open to the public; excludes travel to and from garage.

Missed Trips: The vehicle arrives outside of the pick-up window and the rider does not take the trip.

Untimely Pick-Ups: Any pick-up that occurs outside of the scheduled pick-up window in which the rider boards the vehicle and takes the trip.

Trip Denials: Trips that cannot be offered within one hour before or after the requested time.

Excessive Trip Length: Any trip that is more that 15 minutes longer than the comparable fixed route travel time including transfer and waiting times.





Construction:

I-94 & US-127 – Install cameras and/or permanent message boards near Airport Road, Parnall Road, Page Ave, I-94/US-127 south interchange, Hawkins Road, Whipple Road, and Grass Lake Scales. Message boards installed and working on communication connections.

I-94 at Elm Road, Lansing Ave. and West Ave (US-127 west), also includes resurfacing on US-127 (I-94 to Parnall) – Earthwork, temporary paving and storm sewer work is occurring at the Elm Road interchange. Concrete paving has been occurring on EB I-94 near West Ave and on West Ave under I-94. Minor bridge work is finishing up on Elm Road over 94 and on EB I-94 over West Ave.

US-127 bridges over M-50/Railroad (just north of McDevitt) – Deck replacement and superstructure repairs. US-127 is down to one lane in each direction and traffic is on the southbound bridge. Additional deterioration has been found on the northbound bridge and repairs are being made to the piers and beams. The NB 127 entrance ramp from M-50 is closed.

Railroad bridges over Jackson Street and Mechanic Street in downtown Jackson – Bridge replacements. Construction began on March 14, 2022, with Mechanic, Jackson, Detroit, and Van Buren Streets being closed near the project. Work is occurring on the bridge foundations and retaining walls at Jackson Street and Mechanic Street.

I-94 from M-60 to Calhoun County line – Reconstruction from M-60 to Michigan Ave, major rehabilitation from Michigan Ave to Calhoun County line – (2022-2024 construction). The contractor has been rebuilding the median (left) shoulder and constructing cross overs from the Calhoun County line to near Parma Road. HMA paving is expected to occur on these areas near the week of May 9th. Single lane closures are occurring Monday morning thru Friday morning.

Lakelands Trail from near Hawkins to Parnall – Non-motorized trail extension. Tree clearing done and clean up is occurring. The contractor is mobilizing to begin major grading activities.

I-94 Westbound from Mt. Hope Road to Washtenaw County line – Capital preventative maintenance resurfacing (2023 construction)
