<u>Steward Street: RR to Ganson (Urban)</u> – Mill and asphalt resurface with curb repairs and signal reconstruction at Ganson. All surface and subsurface work is complete. **Delivery of signal poles and mast arms is confirmed for the first week of July 2022. Installation is scheduled for the week of July 11, 2022.** 

<u>Wisner St Traffic Signals (HSIP) Ganson, North and Argyle</u> – Replacement of the existing traffic signals at these three intersections with mast arm signals. **All poles, arms, signal heads and associated conduits, conductors and controllers are installed.** Currently awaiting Consumer's service connection.

#### 2022

<u>E. High Street Bridge over the Grand River</u> – Replacement of the existing bridge superstructure. **Steel beam delivery is confirmed for July 11 and 12.** 

West Avenue Signals at Franklin, Washington and Morrell with Ganson and Elm Signal - Reconstruct Signals on West Ave at Franklin and Morrell with Signal at Ganson and Elm. Contractor is Wright Electric Co. Water main work is complete. Removals are currently in process. Signal pole foundation installations will commence immediately after removals are complete.

Greenwood Ave: Fourth St to Morrell St with Greenwood/Fourth & Fourth/Prospect Signals - Mill and HMA Resurface on Greenwood with signal replacements at the intersections. Contractor is Michigan Paving and Materials Co. Sidewalk repairs and ramp upgrades on the east side of Greenwood are complete. Signal pole foundations at Griswold intersection and Fourth and Prospect intersection have been installed. Milling on the east half of Greenwood is scheduled for July 7th. The milled surface will be repaved with a single course of HMA shortly thereafter.

<u>Brown Street: Morrell to Michigan – Mill and repave, relocate curb and construct non-motorized trail on east side.</u> Spaulding DeDecker is the consultant on this project.

#### PROJECT REPORT 2020-2023 TIP

#### August 2022

#### 1. Grants

- a. We are continuing to seek out competitive grant opportunities to fund TIP approved projects.
- b. We are in the process of completing our annual application for formula funding through the FTA. Our application is currently in the "Initial Review/Concurrence" status, which means our FTA program manager has reviewed and approved it.

#### 2. Vehicle Procurements

- a. We have finally received pricing from Gillig for the new buses with options such as, the driver barrier, installation of a bike rack, and the use of the Quantum automated wheelchair securement position instead of the traditional wheelchair restraints. We have confirmed the options requested, ensuring each of the three (3) buses we are having manufactured are configured the same. The approved increase in pricing through the Washington state contract was roughly 11% due to increases in the Producer Price Index (PPI). The PO for the purchase of the two (2) additional vehicles was issued on July 26<sup>th</sup> and we received approval from the State of Washington Dept. of Enterprise Services for the purchase on July 29<sup>th</sup>.
- b. We submitted to Hoekstra an order for three (3) new Ford Transit vans. The current wait time for manufacture and delivery of the vehicles is approximately 6-8 months. These vehicles are being procured through a State of Michigan vehicle contract.

#### 3. Bus & Bus Components

a. As previously reported, we are working with the State of Michigan, through MDOT, to procure automated wheelchair securements. This project involves retrofitting six (6) of the city buses in our current active fleet with the new wheelchair securement positions as well as retrofitting the seating to be compatible with the new wheelchair positions. The vendor chosen for this procurement by MDOT is Q'Straint. On April 4<sup>th</sup>, we submitted the purchase order to get this project in motion. We had anticipated receiving the equipment by July 2022 and we have received the wheelchair restraints, however, we are still waiting on the retrofitted seating to arrive from American Seating so we can begin installation.

#### 4. Facility Upgrades

- a. We have received the site plans as well as the bidding specifications for a final review from the engineering and architectural firm, Fishbeck, for the concrete replacement project at the downtown Transfer Center. We are in the process of drafting the invitation for bid (IFB).
- b. The overhead doors for our maintenance and bus storage facilities are weathered, worn, and becoming cost prohibitive to maintain. I have been able to secure approval from the FTA to reallocate funds from older grants to finance a project to replace these doors throughout our facility. MDOT has approved the updated project as well. The RFQ has been issued for this

project. It was published through BidNet on July 15<sup>th</sup> and we announced the publication on our website as well as the contracting opportunities page through MDOT.

#### September 2022

#### 1. Grants

- a. We are continuing to seek out competitive grant opportunities to fund TIP approved projects.
- b. We are in the process of completing our annual application for formula funding through the FTA. Our application is currently in the "Final Concurrence/Reservation" status, which means our application is in the final stages of approval. We have received our concurrence letter from the Dept. of Labor and are just waiting now for the award to go into "active" status.

#### 2. Vehicle Procurements

a. No new updates.

#### 3. Bus & Bus Components

a. As previously reported, we are working with the State of Michigan, through MDOT, to procure automated wheelchair securements. This project involves retrofitting six (6) of the city buses in our current active fleet with the new wheelchair securement positions as well as retrofitting the seating to be compatible with the new wheelchair positions. The vendor chosen for this procurement by MDOT is Q'Straint. On August 29<sup>th</sup>, installers from Q'Straint came to our facility to begin installing the wheelchair positions and to train our mechanics how to install them. As of this report, we have two (2) buses on the road with the new Quantum wheelchair positions and our maintenance department is working on completing the installation of the four (4) additional ones.

#### 4. Facility Upgrades

- a. We have received the site plans as well as the bidding specifications for a final review from the engineering and architectural firm, Fishbeck, for the concrete replacement project at the downtown Transfer Center. We are in the process of drafting the invitation for bid (IFB).
- b. The overhead doors for our maintenance and bus storage facilities are weathered, worn, and becoming cost prohibitive to maintain. I have been able to secure approval from the FTA to reallocate funds from older grants to finance a project to replace these doors throughout our facility. MDOT has approved the updated project as well. As the original solicitation was nearing its closing date and we had yet to receive any bids, we issued an addendum to update the solicitation to close at a later date and to update the site visit requirement to recommended.

#### 5. Training

a. We, like many transit agencies around the state, are having issues finding drivers. This was made more difficult when new rules for CDL operator licensure which were handed down by the FMCSA went into effect in February of this year. After having

attended the Michigan Public Transit Association (MPTA) conference in August and having conversations with others in our same predicament, we learned about a training program which fully complies with FMCSA, FTA and PTASP regulations which will allow us to provide CDL training at our facility. We received the training program and registered as an organization through the Trainer Provider Registry (TPR) and once approved as a training facility will be able to provide the theory and behind-the-wheel training required for new CDL drivers as well as administer their final exams.

#### **Construction:**

**I-94 & US-127** – Install cameras and/or permanent message boards near Airport Road, Parnall Road, Page Ave, I-94/US-127 south interchange, Hawkins Road, Whipple Road, and Grass Lake Scales. Message boards were used for the recent I-94 closure. Final acceptance is still pending interfacing with the cameras and traffic data.

I-94 at Elm Road, Lansing Ave. and West Ave (US-127 west), also includes resurfacing on US-127 (I-94 to Parnall) – Earthwork, concrete paving and storm sewer work is occurring at the Elm Road interchange. Concrete paving will continue to occur on the DDI at West Ave under I-94. EB I-94 traffic was shifted to the new concrete pavement on the eastbound side from Airport to near Elm Road. The Elm Road bridge, EB exit ramp to Elm Road, WB entrance ramp from Elm and Seymour Road have all been closed until late September when the new bridge and roundabouts are expected to open.

**I-94 from M-60 to Calhoun County line** – Reconstruction from M-60 to Michigan Ave, major rehabilitation from Michigan Ave to Calhoun County line – (2022-2024 construction). Traffic is shifted into a split merge configuration from Michigan Ave to the Calhoun County line with two lanes maintained on EB 94 all the time. WB will have single lane closures from Monday thru Thursday for HMA paving and earthwork along WB I-94. The I-94/Michigan Ave interchange is closed until near September 1<sup>st</sup> to rebuild the interchange with roundabouts. Bridge repair work is occurring at several bridges over I-94.

**US-127 bridges over M-50/Railroad (just north of McDevitt)** – Deck replacement and superstructure repairs. US-127 is down to one lane in each direction and traffic is on the southbound bridge. Additional deterioration has been found on the northbound bridge and repairs are being made to the piers and beams. The NB 127 entrance ramp from M-50 is closed. The beams have been set on the NB 127 bridge and the deck should be poured within the next several weeks.

Railroad bridges over Jackson Street and Mechanic Street in downtown Jackson – Bridge replacements. Construction began on March 14, 2022, with Mechanic, Jackson, Detroit, and Van Buren Streets being closed near the project. Work is occurring on the bridge foundations and retaining walls at Jackson Street and Mechanic Street. Due to utility issues, bridge work will also occur in 2023.

**Lakelands Trail from near Hawkins to Parnall** – Non-motorized trail extension. Most of the aggregate base is placed and surface aggregate being installed. Work is occurring along Parnall Road near Cooper Street.

**Annual pavement marking – Countywide state roadways.** Work is underway.

Asphalt Crack Sealing – Various state roadways. Work is underway.

**Signing upgrade on M-50, I-94 BL (E. Michigan Ave), M-124 -** August 2022 letting and work will begin this fall.

#### Design:

M-106 (Cooper St.) – Signing upgrade from Michigan Ave to M-52— Non-freeway signing upgrade (2023 construction).

**I-94 Westbound from Mt. Hope Road to Washtenaw County line** – Capital preventative maintenance resurfacing (2023 construction)

Traffic signal modernization on Cooper Street and MLK (Washington, Glick, Ganson, Leroy, Parnall, South, Morrell, & High. MLK at Ganson.) – Late 2023 construction.

M-50 from Valley Farm Road to Lincoln Road – Shoulder paving (2023 construction).

Cooper Street (M-106) bridge replacement in downtown Jackson south of train station and Louis Glick (I-94BL) deck replacement near Mechanic Street – (2024 Construction).

**US-127 Freeway Signing Upgrade (I-94 to Ingham County Line and M-50 to I-94)** – (2024 Construction).

US-127 (Henry to near Ingham Co Line) – state funds only, major resurfacing (future construction).

**I-94 at Airport Road interchange** – Operational study to review alternatives (future construction).

#### **Construction:**

**I-94 & US-127** – Install cameras and/or permanent message boards near Airport Road, Parnall Road, Page Ave, I-94/US-127 south interchange, Hawkins Road, Whipple Road, and Grass Lake Scales. Message boards were used for the recent I-94 closure. Final acceptance is still pending interfacing with the cameras and traffic data.

I-94 at Elm Road, Lansing Ave. and West Ave (US-127 west), also includes resurfacing on US-127 (I-94 to Parnall) – Earthwork, concrete paving and storm sewer work is occurring at the Elm Road interchange. Concrete paving will continue to occur on the DDI at West Ave under I-94. EB I-94 traffic was shifted to the new concrete pavement on the eastbound side from Airport to near Elm Road. The Elm Road bridge, EB exit ramp to Elm Road, WB entrance ramp from Elm, the EB entrance from Elm, and Seymour Road have all been closed until late September when the new bridge and roundabouts are expected to open. EB I-94 traffic was shifted to the WB roadway to allow reconstruction of EB I-94 from Elm to US-127 south.

**I-94 from M-60 to Calhoun County line** – Reconstruction from M-60 to Michigan Ave, major rehabilitation from Michigan Ave to Calhoun County line – (2022-2024 construction). Traffic is shifted into a split merge configuration from Michigan Ave to the Calhoun County line with two lanes maintained on EB 94 all the time. WB I-94 will have single lane closures for HMA paving and earthwork. The I-94/Michigan Ave interchange is closed until near September 16<sup>th</sup> to rebuild the interchange with roundabouts. Bridge repair work is occurring at several bridges over I-94.

**US-127 bridges over M-50/Railroad (just north of McDevitt)** – Deck replacement and superstructure repairs. US-127 is down to one lane in each direction and traffic is on the southbound bridge. The US-127 NB bridge deck was poured before Labor Day and is expected to be completed near the end of September. The schedule for work on the southbound US-127 bridge is being discussed and may extend through the winter.

Railroad bridges over Jackson Street and Mechanic Street in downtown Jackson – Bridge replacements. Work is occurring on the bridge foundations and retaining walls at Jackson Street and Mechanic Street. Railroad traffic is scheduled to be switched to the north tracks to allow the south tracks to be closed. This will allow work to begin on the retaining walls on the south side of the bridges. Due to utility issues, bridge work will also occur in 2023. Discussions regarding opening Jackson Street and Mechanic Street for this winter are underway.

**Lakelands Trail from near Hawkins to Parnall** – Non-motorized trail extension. Most of the aggregate base is placed and surface aggregate being installed. The trail has been paved along Parnall Road near Cooper Street.

Annual pavement marking – Countywide state roadways. Work is underway.

Asphalt Crack Sealing – Various state roadways. Work is underway.

**Signing upgrade on M-50, I-94 BL (E. Michigan Ave), M-124 -** Project was let on August 5<sup>th</sup>, and work will begin this fall.

**M-106** (Cooper St.) – Signing upgrade from Michigan Ave to M-52— Non-freeway signing upgrade (2023 construction).

**I-94 Westbound from Mt. Hope Road to Washtenaw County line** – Capital preventative maintenance resurfacing (2023 construction)

At the December 2021 JACTS TAC/Policy Committee meetings, both committees approved the NFC reclassification of Monroe Street (between M-124 and Brooklyn Village Limit) and Monroe Pike (between Brooklyn Village Limit and M-50) from an NFC-7 (Local) designation to an NFC-6 (Minor Collector) designation.


Since then, both the Village of Brooklyn and the Jackson County Department of Transportation (JCDOT) have indicated that the more appropriate classification for these roads is NFC-5 (Major Collector). Per the Federal Highway Administration's (FHWA) NFC guidelines, JCDOT, the Village of Brooklyn and R2PC must be in agreement regarding the proposed NFC reclassification. As a result, R2PC staff is requesting both committees approve the reclassification of Monroe Street and Monroe Pike to an NFC-5 (Major Collector) designation.

JCDOT is also proposing to change the NFC classification of Blackman Road (between Springport Road to County Farm Road) from an NFC-7 (Local) to NFC-5 (Major Collector).




