Contractor is Wright Electric Co. Signal pole foundations are complete Signal pole delivery around April 2023. All remaining work on West Avenue is complete until poles come in. Road is open to traffic.

Greenwood Ave: Fourth St to Morrell St with Greenwood/Fourth & Fourth/Prospect Signals - Mill and HMA Resurface on Greenwood with signal replacements at the intersections. Contractor is Michigan Paving and Materials Co. Signal pole foundations are all complete. Signal pole delivery around April 2023. All remaining work is complete until poles come in. Road is open to traffic.

<u>Greenwood at High Signal:</u> Signal replacement with new mast arm signal – HRC is the consultant on the project. J Ranck Electric is the contractor. **Preconstruction Meeting was held on December 6, 2022.**

#### Fiscal Year 2022

#### **STUL (Urban) Federal Aid Projects**

#### JN 207169 South Street Preventive Maintenance

Documents have been submitted for a February 2023 letting. Construction will be in during the 2023 construction season.

#### **STP Local (Rural) Federal Aid Projects**

### JN 215587 - Holibaugh Road

Low bidder in the November 2022 letting is Lakeland Asphalt Corporation.

Low bid was 12.92% under engineer's estimate.

#### U.S. Economic Development Administration (EDA) Grant Project

County Farm/Springport Corridor Improvements and Jackson Technology Park – North Construction Mead Brothers has begun earthwork on the technology park has begun and will continue through December. Sanitary sewer work began in December and will require lane closures along Springport Road. Weekly progress meetings are scheduled for every Monday at noon during the project.

Final documents have been submitted. The fieldwork for the Phase II study is complete. The archeology report is expected to be complete in early December, which will then be submitted to the Michigan State Historic Office for review and approval. #### **Construction:**

I-94 at Elm Road, Lansing Ave. and West Ave (US-127) also includes resurfacing on US-127 (I-94 to Parnall) — The West Ave interchange (DDI) is open to traffic. I-94 traffic is shifted back to the permanent lanes for the entire project. Minor signing and guardrail work may occur over the winter. Major work remains near the Elm Road interchange in 2023 and on US-127 from Springport to Parnall.

**I-94 from M-60 to Calhoun County line** – Reconstruction from M-60 to Michigan Ave, major rehabilitation from Michigan Ave to Calhoun County line – (2022-2025 construction). The project is mostly shut down for the winter. Some minor pipe work will be occurring this winter that won't impact traffic. HMA paving will resume in the spring from Michigan Ave to the Calhoun County line. Work will also begin to rebuild the portion from M-60 to Michigan Ave in the spring.

US-127 bridges over M-50/Railroad (just north of McDevitt) – Deck replacement and superstructure repairs. US-127 is down to one lane in each direction. Traffic is on the new northbound US-127 bridge and will remain there through the winter. Structure repair work will continue over the winter on the US-127 southbound bridge. The completion date is still being analyzed but is expected to be summer 2023.

Railroad bridges over Jackson Street and Mechanic Street in downtown Jackson – Bridge replacements. The project is mostly shut down for the winter. Some work may occur in the contractor's staging areas over the winter. Both railroad tracks are back in service for the winter. Due to utility issues, significant work will occur in 2023. Jackson Street and Mechanic Street are open. Detroit and VanBuren Streets will remain closed over the winter.

Signing upgrade on M-106 (Cooper St) M-50, I-94 BL (E. Michigan Ave), M-124 – Work is underway and will continue through 2023.

**I-94 Westbound from Mt. Hope Road to Washtenaw County line** – Capital preventative maintenance resurfacing. Work will occur in late spring/summer 2023.

M-50 from Valley Farm Road to Lincoln Road – Shoulder paving. Work will occur summer 2023.

#### Design:

Traffic signal modernization on Cooper Street and MLK (Washington, Glick, Ganson, Leroy, Parnall, South, Morrell, & High. MLK at Ganson.) – (Late 2023 construction).

Cooper Street (M-106) bridge replacement in downtown Jackson south of train station and Louis Glick (I-94BL) deck replacement near Mechanic Street – (2024 Construction).

US-127 Freeway Signing Upgrade (I-94 to Ingham County Line and M-50 to I-94) – (2025 Construction).

US-127 (Henry to near Ingham Co Line) – Maintenance resurfacing (future construction).

**I-94 at Airport Road interchange** – Operational study to review alternatives (future construction).

A meeting was held on December 14, 2022 between the City of Jackson, JATA, and JCDOT, along with Region 2 Planning Commission staff, to discuss allocating extra funding.

The total allocation is \$770,357 and needs to be obligated in FY 2023. The results of the discussion were that JCDOT is to receive \$450,357 for signal modernization at the Badgley and Horton and McCain and Robinson intersections. The City of Jackson is to receive \$320,000 for North Street reconstruction from Wisner Street to West Ave.
