2022

West Avenue Signals at Franklin, Washington and Morrell with Ganson and Elm Signal - Reconstruct Signals on West Ave at Franklin and Morrell with Signal at Ganson and Elm. Contractor is Wright Electric Co. Signal pole foundations are complete Signal pole delivery around April 2023. All remaining work on West Avenue is complete until poles come in. Road is open to traffic.

Greenwood Ave: Fourth St to Morrell St with Greenwood/Fourth & Fourth/Prospect Signals - Mill and HMA Resurface on Greenwood with signal replacements at the intersections. Contractor is Michigan Paving and Materials Co. Signal pole foundations are all complete. Signal pole delivery around April 2023. All remaining work is complete until poles come in. Road is open to traffic. Contractor is installing Signal controller and pedestrian signals in preparation for mast arms arriving soon.

<u>Greenwood at High Signal:</u> Signal replacement with new mast arm signal – HRC is the consultant on the project. J Ranck Electric is the contractor. During the milder part of January the contractor installed the underground conduits and the pole bases.

<u>Brown Street: Morrell to Michigan – Mill and repave, relocate curb and construct non-motorized trail on east side.</u> Spaulding DeDecker is the consultant on this project. Gl Meeting was held on September 7th. **Anlaan is the as read low bid at 4% over the engineers estimate.**

<u>Wildwood Avenue: West Ave to Steward</u> – Mill and HMA Resurface. Spaulding DeDecker is the consultant on this project. GI Meeting was held on September 7th. Plans are at MDOT waiting for a letting.

<u>Wisner Street: Wildwood to Ganson</u> – Mill and HMA Resurface. Spaulding DeDecker is the consultant on this project. GI Meeting was held on September 7th. Plans are at MDOT waiting for a letting.

<u>Crosswalk Enhancements at 5 Locations (HSIP)</u> – Sidewalk ramps, LED bordered signs, along non-motorized paths. HRC is the consultant on this project. GI Meeting was held on September 28th. Project will be in the April MDOT letting.

North Street: Wisner to West Ave – Pavement Replacement. Spaulding DeDecker is the consultant on the project. **Grade Inspection Meeting is scheduled with MDOT on March 8**th.

We would like to provide the following update regarding our projects that are on the Transportation Improvement Program (TIP) for FY 2022, 2023, and 2024.

Fiscal Year 2022

STUL (Urban) Federal Aid Projects

JN 207169 South Street Preventive Maintenance

Project was in the February 2023 letting. Low bidder was Michigan Paving & Materials. Construction will be in during the 2023 construction season. Low bid was \$734,866, which was 4.70% over Engineer's estimate.

JN 216632 Urban Pavement Markings

Project was in the February 2023 letting. Low bidder was PK Contracting. Only one bid was received for this project. Low bid was \$184,223, which was 9.48% over Engineer's estimate. Construction will be during summer 2023.

STP Local (Rural) Federal Aid Projects

JN 215587 - Holibaugh Road

Low bidder in the November 2022 letting is Lakeland Asphalt Corporation.

Low bid was 12.92% under engineer's estimate. Construction will be during the 2023 construction season.

U.S. Economic Development Administration (EDA) Grant Project

County Farm/Springport Corridor Improvements and Jackson Technology Park – North Construction

- Mead Brothers is continuing earthwork, sanitary sewer and storm sewer installation on the technology park as weather allows. Earthwork has been slow due to wet weather, but will pick up as the weather improves.
- Consumers Energy has finished gas main installation for the east half of the project. Gas main in front of the JSP will be scheduled soon.
- Signal foundations and directional boring has been completed for County Farm and Airport Road Intersection. Remaining signal materials are scheduled for delivery in July.
- LED Stop Signs and the flashing signal have been installed. Currently waiting on Consumers to provide power for the flashing signal.

Weekly progress meetings are scheduled for every Monday at noon during the project.

<u>Transportation Alternatives Program (TAP) Grant – Shared-use Pathway Project</u> JN 210635 Mike Levine Lakelands Trail Extension

The Michigan Department of Environment, Great Lakes, and Energy is requiring hazardous material testing through the Consumers easement. Met with the property owners on Lansing Avenue for this project, and they have voiced concerns about selling property for the trail. Other trail routes are currently being reevaluated to avoid property acquisition from private property owners.

Construction:

I-94 at Elm Road, Lansing Ave. and West Ave (US-127) also includes resurfacing on US-127 (I-94 to Parnall) – Major work remains near the Elm Road interchange and on US-127 from Springport to Parnall. Work began on February 28th on I-94 near the Elm Road interchange. All I-94 traffic will be shifted to the EB roadway and the WB exit ramp to Elm/Seymour will be closing within the next couple weeks, depending on the weather.

I-94 from M-60 to Calhoun County line – Reconstruction from M-60 to Michigan Ave, major rehabilitation from Michigan Ave to Calhoun County line – (2022-2025 construction). Work is scheduled to begin near March 6th. HMA paving will resume in the spring from Michigan Ave to the Calhoun County line. Work will also begin to rebuild the portion from M-60 to Michigan Ave in the spring.

US-127 bridges over M-50/Railroad (just north of McDevitt) – Deck replacement and superstructure repairs. US-127 is down to one lane in each direction. Traffic is on the new northbound US-127 bridge and will remain there through the winter. Structure repair work will continue over the winter on the US-127 southbound bridge. The completion date is still being analyzed but is expected to be summer 2023.

Railroad bridges over Jackson Street and Mechanic Street in downtown Jackson – Bridge replacements. Work is scheduled to resume near March 1st and Mechanic Street will be closed until the fall. The track shutdown and bridge deck replacement is scheduled for August for both bridges. Jackson Street will remain open until later this summer.

Signing upgrade on M-106 (Cooper St) M-50, I-94 BL (E. Michigan Ave), M-124 – Work is underway and will continue through 2023.

I-94 Westbound from Mt. Hope Road to Washtenaw County line – Capital preventative maintenance resurfacing. Work will occur in late spring/summer 2023.

M-50 from Valley Farm Road to Lincoln Road – Shoulder paving. Work will occur summer 2023.

Cooper (M-50/US-127BR) over abandon RR, north of High and south of Morrell – Preventative maintenance bridge repairs. 2024 construction.

Traffic signal modernization on Cooper Street and MLK (Washington, Glick, Ganson, Leroy, Parnall, South, Morrell, & High. MLK at Ganson.) – (Late 2023 construction).

Design:

Cooper Street (M-106) bridge replacement in downtown Jackson south of train station and Louis Glick (I-94BL) deck replacement near Mechanic Street – (2024/2025 Construction).

US-127 Freeway Signing Upgrade (I-94 to Ingham County Line and M-50 to I-94) – (2025 Construction).

Dear Director Hurt:

This letter is sent by the Michigan Department of Transportation (MDOT) to inform the Jackson Area Comprehensive Transportation Study committees of a Transportation Improvement Plan (TIP) amendment to the FY 2023-2026 TIP.

Proposed TIP Amendments:

- 1) The currently programmed FY 2023 programmed project (JN 213386: US-12 and M-99 in Jonesville) is being moved to FY 2024 to coordinate with the City of Jonesville. The proposed FY 2023 new project is M-50.
- 2) A traffic Safety project is being added to FY 2023 for pavement marking retroflecitivity readings.
- 3) The following proposed amendments are all Capital Preventative Maintenance (CPM) projects that are being added to the TIP due to the FY 2028 Trunkline Call for Projects that has now been approved.
 - a. I-94 BL
 - b. M-99
 - c. M-50
- 4) US-127, Henry Road to the County Line, Project has had been approved as a Road Rehabilitation project, but now is updated to be a CPM Project. The changes in work scope and budget have triggered the proposed federal amendment. The changes are necessary to keep fiscal constraint due to over programming and increased costs associated with inflation.

Resolution to Approve the Reaffirmation of the 2045 Long Range Transportation Plan for the Jackson Area Comprehensive Transportation Study

Whereas, The Jackson Area Comprehensive Transportation Study (JACTS) is the designated Metropolitan Planning Organization (MPO) for the Jackson, Michigan urban area; and

Whereas, the JACTS 2045 Long Range Transportation Plan had a planning horizon of at least 20 years when developed and this plan can be amended periodically upon request with the appropriate documentation supporting such a request; and

Whereas, the JACTS 2045 Long Range Transportation Plan has an effective date of June 2018; and

Whereas, the JACTS Long Range Transportation Plan must be updated every five years to confirm its validity and consistency with current and forecasted trends and to extend the planning horizon if necessary; and

Whereas, JACTS has reviewed the population and employment forecasts for 2045 and find that they are still valid; and

Whereas, JACTS has reviewed the travel forecasts, capacity deficiencies, and the proposed improvements in the JACTS 2045 LRTP and find that they are still valid; and

Whereas, the JACTS 2045 Long Range Transportation Plan was developed through a process that included input from the public, affected public agencies and other interested parties, and

Whereas, the JACTS 2045 Long Range Transportation Plan can be amended periodically upon request with appropriate documentation to support such a request.

The Jackson Area Transportation Study (JACTS) has reaffirmed the JACTS 2045 Long Range Transportation Plan (LRTP) through December 31, 2023. No additional changes were made to the document. In accordance with JACT's Public Participation Plan, there was an ample public comment period for the 2045 LRTP reaffirmation. Included with this letter is supporting documentation for the comment period, for the action taken by the JACTS Policy Committee, and a schedule for completion of the LRTP update.

Due to ongoing impacts of the COVID-19 pandemic and significant staff turnover, JACTS staff realized that the process of completing the update of JACTS LRTP to a horizon of 2050 was not going to be able to be completed with an adequate public review period by the June 30, 2023 deadline. Therefore, the current reaffirmation was decided up on by JACTS staff along with MDOT staff who were in contact with FHWA and FTA staff.

As confirmed with MDOT staff, a new conformity document will not need to be created for the Jackson MPO until a new LRTP or TIP is developed. This will provide more than enough time to take the 2050 LRTP through the public participation process and receive the necessary approvals.

The Michigan Department of Transportation (MDOT) is pleased to announce the solicitation of applications for the Fiscal Year (FY) 2025 Local Safety Program encompassing the Highway Safety Improvement (HSIP), Highway Safety Improvement (HSIP) Systemic, and High-Risk Rural Road (HRRR) programs. The FY 2025 federal budget apportioned for this program is estimated to be \$20,684,000:

- \$12,684,000 for general HSIP
- \$2,000,000 for streamlined systemic HSIP
- \$6,000,000 for HRRR

These amounts may be subject to revisions.

We are asking the County Road Association of Michigan to distribute this notice to members.

Local agencies may submit up to three Streamlined Systemic Application Forms for consideration. There is no limit to the number of HSIP and/or HRRR Application Forms that an agency may submit. An agency wishing to submit a systemic horizontal curve delineation, rumble strips, edge line pavement markings, signal backplates, countdown pedestrian signals, or stop controlled intersection sign upgrade project is encouraged to use the HSIP Streamlined Systemic Application Form.

In FY 2024, the State of Michigan is subject to a new Vulnerable Road User (VRU) Rule. It is likely the State will also be subject to the rule for the foreseeable future. Therefore, a new VRU financial goal of \$3,000,000 has been added in Exhibit 2. For more information regarding VRU projects, please refer to the information provided in Exhibits 2 and 5.

Federal safety funds shall not exceed \$1,500,000 per Local Agency for the fiscal year. Any non-selected HRRR projects will be automatically considered for general FY 2025 HSIP safety funds. Selected projects are to be obligated in FY 2025.
