Mr. Merillat led Committee members through a review of the projects. The Committee concurred with the Small Urban projects as listed for FY 2022 and FY 2023.

**ITEM 7**      **Review of MDOT Funding Updates**

Staff announced that the Adrian, Tecumseh, Clinton Small Urban Area is allocated \$385,000 per year for FY 2024 – FY 2026

**ITEM 8**      **Review and Selection of FY 2024 – FT 2026 Proposed Projects**

2024 – City of Tecumseh: S. Adrian Street, M-50 to Russell Road (0.81 miles). Mill and resurface. \$385,000 STP funds, \$96,250 local match, \$481,250 total

2025 – City of Adrian: Gulf Street, Maumee to Beecher. Reconstruct. \$385,000 STP funds, \$96,250 local match, \$481,250 total

2026 – Lenawee County Road Commission: Wolf Creek Highway, US-223 to Hunt Road (1.98 miles), and Valley Road, Bent Oak Highway to M-52 (1.68 miles). Mill and resurface. \$385,000 STP funds, \$96,250 local match, \$481,250 total

A motion was made by Ms. Daisher, supported by Mr. Swallow, to approve the Adrian, Tecumseh, Clinton Small Urban Area projects for FY 2024 – FY 2026. The motion passed unanimously.
