#### **Construction:**

I-94 at Elm Road, Lansing Ave. and West Ave. (US-127) reconstruction, also includes resurfacing on US-127 (I-94 to Parnall) — Clean up, turf establishment and other various items of work remain.

I-94 from M-60 to Calhoun County line – Reconstruction from M-60 to Michigan Ave, major rehabilitation from Michigan Ave to Calhoun County line – (2022-2025 construction). Lane closures will be occurring on Monday morning until Friday morning on EB and WB I-94, with some weekends, for signing, pavement markings, and other miscellaneous work. Work is expected to wrap up December 20<sup>th</sup> for the season.

Cooper Street (M-106) bridge replacement in downtown Jackson south of train station and Louis Glick (I-94BL) deck replacement near Mechanic Street – Construction on the watermain along Cooper Street is expected to begin in early January, weather permitting. This will require the closure of Cooper Street, and the posted detour will utilize Washington Ave to Louis Glick to MLK to Cooper and vice versa.

**US-127 northbound ramp to Westbound I-94** – Safety project - High friction surface treatment. 2025 construction.

**US-127 at Jefferson Road** – Bridge repairs. 2025 construction.

M-106 over Portage River – Bridge repairs. 2025 construction.

M-50 from Brooklyn to Napoleon – Preventative maintenance - Microsurface. 2025 construction

M-50 at Clark Lake Road – Safety project – Install center left turn lane. 2025 construction.

**M-99 from Village of Springport to M-50** – Preventative maintenance – Chip seal with Fog Seal. 2025 Construction

**M-50 from Hopcraft to near Eaton Rapids** – Preventative maintenance – Chip seal with Fog Seal. 2025 Construction

#### Design:

**Cooper Street (M-106) from Michigan Ave to North Street** – Preventative maintenance resurfacing and sidewalk ramps. 2026 construction.

**Cooper Street (M-106) from Third Street to Chanter** – Preventative maintenance resurfacing. 2026 construction.

## What Is Being Done?

Starting in winter 2024/2025, the Michigan Department of Transportation (MDOT) will be replacing the US-127 Business Route (BR) (Cooper Street) bridge over the Grand River in the city of Jackson. This phase of the project will include water main modernization from Washington Avenue to Michigan Avenue with associated pavement reconstruction. The nonmotorized path along the west side of Cooper Street will be extended north across the new Cooper Street bridge to the Hupp Street intersection area. The construction phase for the Cooper Street bridge is expected to be completed by November 2025.

Starting in early spring 2026, MDOT will be rebuilding the bridge deck and railing on the I-94 Business Loop (BL) (Louis Glick Highway) bridge over the Grand River. This phase of the project will include new bridge approach pavement, sidewalk area improvements and concrete pavement repairs on Louis Glick Highway from Michigan Avenue east to Columbus Street. The construction phase for the Louis Glick Highway bridge and pavement repairs is expected to be completed by November 2026.

### When Will This Be Done?


Season 1: Construction will start in winter 2024/2025 and last though the 2025 construction season.


Season 2: Construction will start in March 2026 and last through the 2026 construction season.

# How Will Traffic Be Affected?

During the rebuilding of the Cooper Street bridge in 2025, Cooper Street will be closed between Washington Avenue and the railroad crossing. Traffic will be detoured using Washington Avenue, Louis Glick Highway, and Marting Luther King Jr. Drive. A short-term closure of the Michigan Avenue/Cooper Street intersection will be required for water main installation. During the intersection closure, traffic will be detoured using Ganson Street, Marting Luther King Jr. Drive, and Jackson Street.



#### RESOLUTION

#### BY CITY COUNCIL:

WHEREAS, Region 2 Planning Commission, being the Metropolitan Planning Organization for the Jackson Urbanized Area, has called for projects for the Transportation Improvement Plan for fiscal years 2026–2029; and

WHEREAS, the Metropolitan Planning Organization, through the Jackson Area Comprehensive Transportation Study, has an estimated \$8,697,000 in federal funds for the four year Transportation Improvement Plan for the local agencies; and

WHEREAS, City Engineering met on August 29, 2024, with Region 2 Planning Commission, Jackson County Department of Transportation and Jackson Area Transportation Authority to select projects to fit within the Federal Funding per year; and

WHEREAS, projects are selected based on construction cost only with Federal Funds paying a maximum of 80% of the cost and City Funds paying the remainder of the cost; and

WHEREAS, projects selected within the City of Jackson for reconstruction and/or rehabilitation are as follows:

#### FY 2026 Ganson Street: Elm to east City Limits

PASER=3, Curb=Good, ADT=7,358, length=0.498 mi

Proposed Work: Mill and asphalt resurface with curb and sidewalk repairs. Estimated Construction Cost = \$692,000 with Federal Portion = \$506,400

#### FY 2027 Morrell Street: Brown to Bowen

PASER=3, Curb=Good, ADT=7,798, length=0.311 mi

Proposed Work: Full depth pavement reconstruction with curb and sidewalk repairs Estimated Construction Cost = \$1,099,000 with Federal Portion = \$879,200

#### FY 2027 Fourth Street at Morrell Street

#### **Motion Requested**

Approve the 2025-2029 Transportation Improvement Program (TIP) project list and the expenditure of the matching funds as required for each project as presented.

#### I. Background

- A. The Jackson Area Comprehensive Transportation Study (JACTS) is the Metropolitan Planning Organization (MPO) responsible for administering and overseeing urban federal grant funding for our area. Projects using federal funds must be approved by both the JACTS Technical and Policy Committees and placed on the TIP.
- B. We have reviewed all federal-aid eligible roads in the Jackson urban area and prioritized projects based on a number of criteria which include traffic volumes, condition of the roads, and safety concerns. Note that only federal-aid eligible roads within the urban area qualify for this funding. Federal-aid eligible roads in the rural area are funded through different grant opportunities.
- C. The various agencies on the JACTS committees worked together to prioritize and select projects for each fiscal year.
- D. Below is a list of projects that have been scheduled. In the event that additional funding becomes available, we also have a list of potential projects to recommend for those opportunities. At this time, approval is only requested for the projects that have been scheduled.

#### **II.** Current Situation

- A. The following is a summary of the projects scheduled for 2026-2029.
  - 1. **Sutton Road** (2025): Overlay 0.63 miles from Michigan Avenue to Ann Arbor Road in Leoni Township. Total estimated project cost is \$200,000, and JCDOT's match is estimated at \$40,000.
  - 2. **Wildwood Ave/West Ganson Street** (2025): Resurface 0.74 miles from Laurence Avenue to North Brown Street. Total estimated project cost is \$296,000, and JCDOT's match is estimated at \$59,200.
  - 3. **Moscow Road** (2025): Overlay 1.26 miles from M-60 to Falling Waters Trail in Spring Arbor Township. Total estimated project cost is \$250,000, and JCDOT's match is estimated at \$62,500.
  - 4. **Clinton Way** (2025): Wedge and Chip 0.68 miles from West Parnall Road to Clinton Road in Blackman Township. Total estimated project cost is \$81,600, and JCDOT's match is estimated at \$16,320.
  - 5. **Dettman Road** (2025): Overlay and Chip 0.45 miles from Gregory Road to Michigan Avenue in Blackman and Leoni Township. Total estimated project cost is \$94,000, and JCDOT's match is estimated at \$18,800.
  - 6. **Robinson Road** (2025): Chip seal 1.44 miles from West Michigan Avenue to McCain Road in Blackman and Summit Township. Total estimated project cost is \$81,878.78, and JCDOT's match is estimated at \$16,375.76.
  - 7. **Shirley Drive** (2026): Resurface 1.88 miles from Parnall Road to Lansing Avenue in Blackman Township. Total estimated project cost is \$1,093,000, and JCDOT's match is estimated at \$218,600.
  - 8. **Wildwood Avenue** (2026): Resurface 0.24 miles from Ganson Street to Wayne Street in Blackman Township. Total estimated project cost is \$100,000, and JCDOT's match is estimated at \$20,000.
  - 9. **Page Avenue Signals** (2026): Signal Modernization at Page/Watts and Page/Falhee in Leoni Township. Total estimated project cost is \$296,000, and no match is required from JCDOT.
  - 10. **Page Avenue** (2027): Wedge and Chip 1.50 miles from US-127 to 5th Street in Leoni Township. Total estimated project cost is \$359,750, and JCDOT's match is estimated at \$71,950.
  - 11. **Springport Road** (2027): Resurface 1.30 miles from Airport Road to Shirley Drive in Blackman Township. Total estimated project cost is \$520,000, and JCDOT's match is estimated at \$104,000.
  - 12. **Falahee Road** (2028): Chip seal 1.40 miles from Page Avenue to Flansburg Road in Leoni Township. Total estimated project cost is \$65,000, and JCDOT's match is estimated at \$13,000.

- 13. **Flansburg Road** (2028): Chip seal 1.40 miles from South Street to Hoyer Road in Leoni Township. Total estimated project cost is \$50,000, and JCDOT's match is estimated at \$10,000.
- 14. **Francis Street** (2028): Wedge and Chip 2.07 miles from McDevitt Avenue to South Street in Summit Township. Total estimated project cost is \$775,000, and JCDOT's match is estimated at \$155,000.
- 15. **Wildwood Avenue** (2028): Resurface 0.76 miles from Michigan Avenue to Laurence Avenue in Blackman Township. Total estimated project cost is \$462,500, and JCDOT's match is estimated at \$92,500.
- 16. **Wildwood Ave Signal** (2028): Signal Modernization at Wildwood/Laurence in Blackman Township. Total estimated project cost is \$271,000, and no match is required from JCDOT.
- 17. **Kibby Road** (2029): Wedge and Chip 4.14 miles from Reynolds Road to City Limits in Spring Arbor and Summit Township. Total estimated project cost is \$424,700, and JCDOT's match is estimated at \$84,940.
- 18. **McCain Road** (2029): Wedge and Chip 2.1 miles from Reynolds Road to Robinson Road in Spring Arbor and Summit Township. Total estimated project cost is \$211,050, and JCDOT's match is estimated at \$42,210.
- B. JACTS requires a resolution of support from the Board of Commissioners approving the project list and the expenditure of the required matching funds for each project. Note that the amounts approved here are only estimates. Updated estimates will be presented as each project gets to the stage where the Board is asked to approve the contract for that project.

#### III. Analysis

- A. **Strategic** Approval of these projects will enhance the quality of the community by improving numerous heavily traveled primary roads. This improves safety and quality of life in the community.
- B. **Financial** The total cost of all 18 projects is estimated to be \$5,717,478.78. The total matching funds required is estimated to be \$1,117,195.76. Those funds will be planned in JCDOT's annual budget for capital road improvements for each of the relevant years.
- C. **Policy/Legal** This request is compliant with all applicable federal, state, and local laws, regulations, and policies.
- D. **Timing** Approval is requested at the Board's convenience.
- **IV. Alternative** The Board could take no action. In that event, JCDOT will take action based on whatever guidance the Board provides.





### **JACKSON AREA COMPREHENSIVE TRANSPORTATION STUDY (JACTS)**

#### Federal Funds Obligated in Fiscal Year 2024

As the state-designated Metropolitan Planning Organization for the Jackson urbanized area, the Region 2 Planning Commission, is responsible for developing and managing a 20-year Long Range Transportation Plan and a short-term, 4-year Transportation Improvement Program (TIP). The current edition of the TIP includes a listing of the approved road, highway, bridge, transit, and non-motorized projects programmed to receive federal and/or state funds in Jackson County during the 2023-2026 Fiscal Years.

The Federal legislation that was adopted in December 2015, Fixing American's Surface Transportation Act (FAST Act), continues the requirement of past legislation that "an Annual Listing of projects, for which federal funds have been obligated in the preceding year shall be published or otherwise made available by the metropolitan planning organization for public review. The listing shall be consistent with the categories identified in the Transportation Improvement Program." This was further enhanced by subsequent bills, including the recently passed Infrastructure Investment and Jobs Act (IIJA) of 2021.

In response to the above directive, the R2PC is providing a listing of all the projects in Jackson County "obligated" during FY 2024 (October 1, 2023 - September 30, 2024). The Federal Highway Administration (FHWA) defines obligated as the federal government's legal commitment to reimburse the implementing agency for the federal share of a project's eligible costs. Although not all obligated projects were initiated or completed during this fiscal year, they have been approved by the FHWA for reimbursement in FY 2024. Some projects actually constructed in FY 2024 were obligated in previous fiscal years and will not appear on this listing.
