Brown Street will be packaged and let with the Blackstone Street project below. **Michigan Paving and Materials Company was low bidder in 03-07-25 letting (1.26% under estimate). Contract award is pending. Precon meeting will be scheduled following award. Construction to commence after 07-07-25 and be completed by 08-15-25.**

221341 Blackstone Street: Glick Hwy to VanBuren Street (bundled with 221339 above): Left turn lanes being added at the intersection of Glick Hwy. Consulting engineering by Hubble, Roth & Clark (HRC). **Construction:**

**I-94 from M-60 to Calhoun County line – Reconstruction from M-60 to Michigan Ave, major rehabilitation from Michigan Ave to Calhoun County line – (2022-2025 construction).** Signing and clean up work will be occurring, depending on the weather. Minor paving and bridge work will occur later this spring.

**Cooper Street (M-106) bridge replacement in downtown Jackson south of train station and Louis Glick (I-94BL) deck replacement near Mechanic Street –** The first phase of watermain construction is nearly complete and bridge work should begin soon.

**US-127 northbound ramp to Westbound I-94 –** Safety project - High friction surface treatment. Work should begin in late April or May.

**US-127 at Jefferson Road –** Bridge repairs. Work should begin in mid-April. Detours will begin near May.

**M-106 over Portage River –** Bridge repairs. Work scheduled to begin near July.

**M-50 from Brooklyn to Napoleon –** Preventative maintenance - Microsurface. Work scheduled to begin near June.

**M-50 at Clark Lake Road –** Safety project – Install center left turn lane. Work scheduled to begin near mid-April.

**M-99 from Village of Springport to M-50 –** Preventative maintenance – Chip seal with Fog Seal. Work scheduled to begin near May.

**M-50 from Hopcraft to near Eaton Rapids –** Preventative maintenance – Chip seal with Fog Seal. Work scheduled to begin near May.

**Cooper Street (M-106) from Michigan Ave to North Street –** Preventative maintenance resurfacing and sidewalk ramps. 2027 construction.

**Cooper Street (M-106) from Third Street to Chanter –** Preventative maintenance resurfacing. 2026 construction.

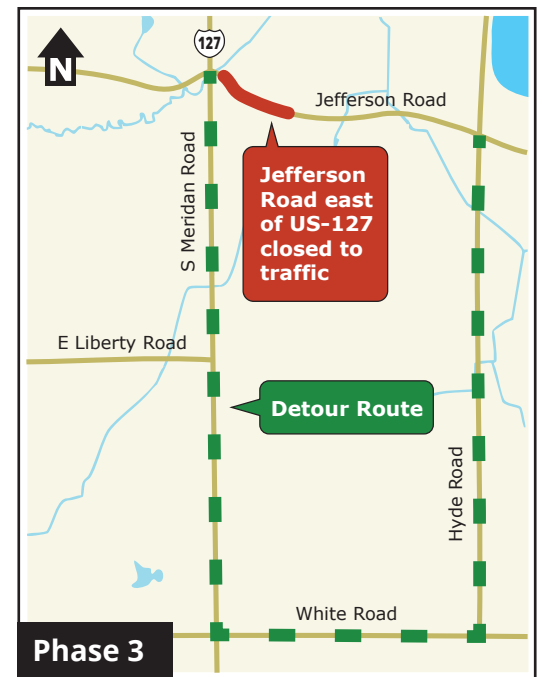
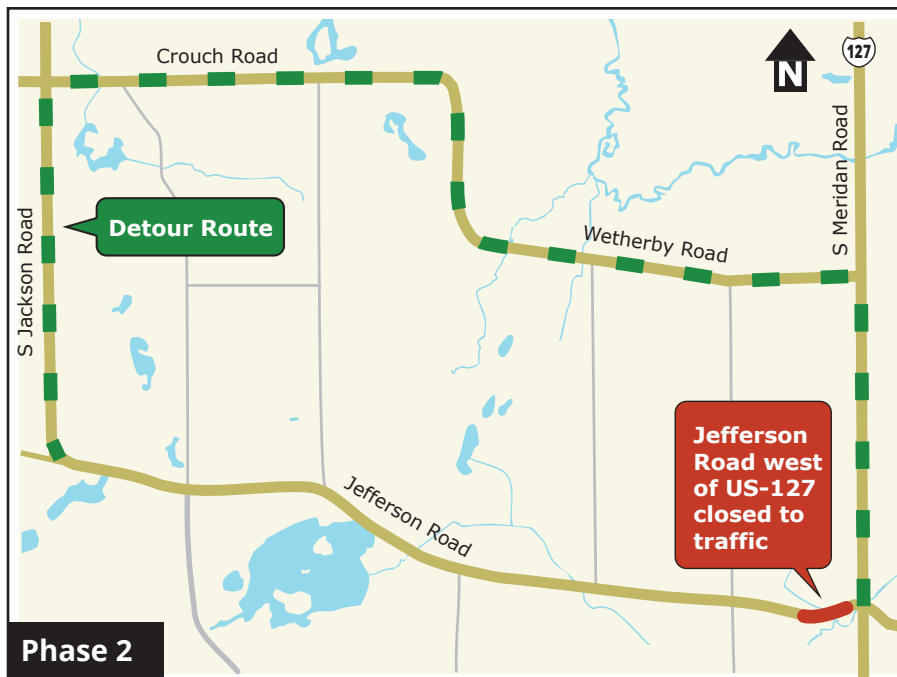
## What Is Being Done?

Starting in early spring, the Michigan Department of Transportation (MDOT) will be completing bridge repairs to the US-127 bridge over the Grand River at Jefferson Road, including deck patches and joint and beam repairs. Work also includes road improvements and widening. Work is expected to be completed by November.

## How Will Traffic Be Affected?

- **Phase 1, April - May:** The northbound shoulder and right-turn lane will be closed during pavement widening along the northbound US-127 shoulder.

- **Phase 2, June - July:** Both directions of US-127 traffic will be shifted onto the northbound shoulder/lane with temporary concrete barrier protecting the work zone during deck and superstructure patching to the southbound half of the bridge. Milling and repaving will also occur on the western leg of the intersection. The western leg of Jefferson Road will be closed and detoured.
- **Phase 3, July - November:** Both directions of US-127 traffic will be shifted onto the southbound shoulder/lane with temporary concrete barrier protecting the work zone during deck and superstructure patching to the northbound half of the bridge. Milling and repaving will take place on the eastern leg of the intersection. The eastern leg of Jefferson Road will be closed and detoured.
