Two new projects were selected for FY 2026, one from the City of Tecumseh and the other from the Lenawee Public Transportation Authority. These projects are found in the table below. A motion was made by Chair Merillat, supported by Ms. Daisher, to approve the proposed projects for FY 2026. The motion carried unanimously.
