Dear Mr. Harkins:

The Region 2 Planning Commission (R2PC), on behalf of Southeast Michigan Prosperity Region 9 (Hillsdale, Jackson, Lenawee, Livingston, Monroe and Washtenaw counties), is pleased to submit the attached grant application for Governor Snyder's Regional Prosperity Initiative (RPI) funding. As both an existing regional planning commission and the federally designated metropolitan planning organization (MPO) for the Jackson Urbanized area, the R2PC has served as the planning, research, and advisory arm to local units of government since 1973. R2PC has a history of promoting and achieving intergovernmental cooperation, coordination, and collaboration and assisting local units of government in achieving their respective goals, and is pleased to have been part of the prosperity Region 9 leadership effort for the 2014 RPI grant.

Prosperity Region 9 partners have made great progress over the last year in working together to develop a common vision for regional prosperity, and evaluating opportunities for increasing collaboration on, or consolidation of services delivery within the region. Working through transportation, industry talent council, workforce and adult education functional groups, we have developed initial goals and objectives for our five-year *Regional Economic Prosperity Strategy*. We are continuing that work and will have a completed strategy by January, 2015. Our functional teams have also developed and begun implementing "working to learn together" projects which are: helping establish a common understanding of needs and issues; identifying models for collaboration and/or consolidation; and building trust and improving coordination among regional organizations. We look forward to continuing the work together in 2015.

In year 2, proposed RPI funds will be used by regional partners to move toward a more organized, formal regional prosperity council (or other similar structure), as outlined in the Governor's Regional Prosperity Initiative and begin implementing that framework by developing collaborative solutions for one or two high-priority and potentially game-changing economic development projects in the region. In addition, grant funds will be used to begin implementing some of the high-priority actions identified in the five-year *Regional Economic Prosperity Strategy* through ongoing work of the functional teams.

We appreciate the opportunity to apply for these important RPI grant funds and are dedicated to moving forward on our vision for regional economic prosperity.

Scope of Work

The focus of Year 1 of the Regional Prosperity Initiative (RPI) collaborative has been on building relationships among leaders and practitioners in the region and identifying priority prosperity issues within two key areas: talent and transportation. To date, this effort has been achieved by establishing and working within four functional teams made up of practitioners and leaders representing all six counties in the region:

- Talent Council (and information technology, health care, and manufacturing subgroups)
- Workforce
- Adult Education
- Transportation

This approach was used because these were areas identified as priorities by Governor Rick Snyder, and there was already some momentum underway for collaborating in these areas within the region. It made sense to start with these areas and then grow the regional collaborative effort from there. The teams are spending the first year identifying key regional issues, developing an initial Strategy for Economic Prosperity (which will be completed by January 2015), and starting collaborative work on specific projects in priority areas (Working to Learn Together projects).

In Year 2, regional partners propose to take the next step of accelerating economic prosperity by moving this grassroots start to a more organized, formal regional prosperity council as outlined in the governor's Regional Prosperity Initiative. The partners also plan to begin implementing some of the high-priority actions identified in the five-year strategy. Specifically, Year 2 will focus on two primary objectives:

- 1) Building a sustainable regional council framework/structure
- 2) Expanding and building on the success of the functional teams

Building a sustainable regional council framework/structure In 2015, partners plan to:

■ Convene regional leaders, including more deliberate engagement of business, political, and philanthropic leaders, for a one-day summit to learn about options for regional public-private collaboration frameworks (best practices from other regions) to advance economic prosperity. The summit will be an engaging and interactive event featuring leaders from other regions who will illustrate for Region 9 stakeholders how public-private regional frameworks have helped accelerate economic prosperity in their region. Participants will be engaged in activities to set a path for establishing a regional council in Region 9.

- Establish an action plan for implementing a selected collaborative council structure (containing a timeline, participants, and required resources) and the five-year strategy.
- Begin to implement the council framework by convening around, and developing collaborative solutions for, one or two high-priority and potentially game-changing economic development projects in the region. This will allow the newly forming regional structure to deploy around a tangible, immediate economic development need; further building on the Working to Learn Together approach developed during Year 1. This effort will bring together regional leaders not only from multiple communities, but from multiple disciplines (talent, education, transportation, housing/community development) and organization types (public, private, nonprofit) to address relevant human services, transportation, infrastructure, land use and economic development needs required to rapidly advance these economic opportunities.

Expanding and building on the success of the functional teams

In Year 2, the region will expand on the functional teams' success and evolve the structure of the teams to be integrated with/into the broader regional council. With continued support, functional teams will:

- Create a Region 9 Talent District Career Council, in alignment with the existing Regional Prosperity Initiative Talent Council, and in support of the regional transportation and other economic development strategies. This will likely result in some consolidation of the existing Talent Council, workforce, and industry subgroups that have been utilized in Year 1 to develop the five-year prosperity strategy.
- Continue to refine a regional adult education strategy that helps improve access to educational offerings, addresses basic skills gaps, and improves learners' success in their career pathway. The strategy will be implemented initially through Washtenaw Intermediate School District's procurement of adult education providers using funds from Section 107 of the School Aid Act. The work will also include aligning the adult education strategy with the consolidations undertaken among Workforce Development Boards, and will be done with oversight from the new regional Talent District Career Council.
- Continue to evaluate options for alignment and possible merger of Michigan Works! agencies' activities and services across Region 9. Additionally, teams will begin transitioning to the facilitation, planning, and board/staff development steps required to implement the agreed-upon changes.
- Use the results from the transportation functional teams' Year 1 Working to Learn Project to evaluate how well the region's current transportation infrastructure meets the needs of talent in the region's priority information technology, health care, and manufacturing sectors.
- Determine whether there is a need for consolidation of transportation planning services, and if so, what the best models are for consolidation of transportation services.
- Establish a challenge grant program to support the functional teams' implementation of some of the most strongly supported and timely strategies included in the five-year strategy. The challenge grant program will continue the Working to Learn Together approach used in the first year of the grant, and will require functional teams to propose key projects that advance the goals of the strategy. Challenge grant projects will be required to have regional impact

- and provide at least a 50 percent match of RPI grant funds in order to leverage the available dollars and broaden the financial commitment of RPI partners.
- Engage functional team members, as appropriate, in the establishment of the regional prosperity council structure and the convening around the identified high-priority economic development project(s). As the process evolves during 2015, some functional teams may be fully absorbed into the new regional council.

Budget

The Region 9 partners are requesting \$250,000 in RPI funding to complete the scope of work described above. A RPI Coordinator will be contracted to provide overall communication among regional partners, develop related documents and deliverables, plan and implement the regional summit, and organize and facilitate meetings of the regional collaborative. In addition, facilitation and implementation support will be provided to the functional teams as they continue evaluating and implementing plans and strategies. A detailed budget is below:

2) Please describe why the region is eligible for the funding tier to which you are applying.

The Region 9 partners are applying to continue their work in Tier 1 of the prosperity initiative: Regional Prosperity Collaborative. Through bringing together public, private, and nonprofit regional partners, the group has begun collaborating and developing a regional prosperity strategy. This includes input from representatives of higher education, adult education, workforce, transportation, and economic development organizations. To date, the group's work has made significant progress in developing a regional vision and five-year prosperity strategy. The group is still working at the collaborative level, but plans to move toward Tier 2: Regional Prosperity Council in 2015. Region 2 Planning Commission has again agreed to be the grantee and is an eligible fiduciary under the Regional Prosperity Initiative requirements.

The group of stakeholders engaged in the R9 prosperity initiative has grown substantially this year, with active engagement of nearly 80 organizations, including:

- 9 individual and intermediate school districts
- 7 higher education institutions
- 4 MichiganWorks! Agencies
- 11 economic development agencies and chambers of commerce
- 8 transportation planning organizations
- 7 municipal or regional planning organizations
- Over 30 private and public health, manufacturing, and information technology, and talent-related industry organizations

Yes. Prosperity Region 9 recognizes its special connections to its adjacent planning areas, especially Prosperity Region 10 (Metro Detroit), and will continue to ensure our plans and RPI efforts are tightly integrated across geographies. A letter of support from the Southeast Michigan Council of Governments, which serves both Region 9 and 10 counties, is included with this application.

1. DEMONSTRATION OF SUCCESS: Please describe your progress toward the deliverables outlined in your application from the last grant cycle. Your response must include evidence of engagement by all required partners, adherence to your budget, proposed timeline, open meetings act, development of your dashboard, prosperity plan and other proposed deliverables.

Region 9 partners have made great progress in the RPI effort's first year. We have engaged over 80 organizations and over 100 people in the process to identify a vision and strategy for regional economic prosperity. Below are highlights of Region 9's accomplishments under our Year 1 grant.

- Convened a multicounty, multidisciplinary project management team (steering committee) who has overseen the grant effort, selected and guided the work of a consultant project coordinator, provided strategic guidance and awarded mini-grants to the four teams for Working to Learn Together projects.
- Convened four functional teams (Workforce, Adult Education, Talent Council, and Transportation) that are made up of public, private, and nonprofit organizations.
 - Talent Council: Four workgroups were formed within this team to explore strategies related to talent attraction and retention, service for special populations, career awareness and readiness for workers from youth to adults, and curriculum alignment with employer demand. In addition, Working to Learn Together RPI grant funding supported two employer cluster subgroups (information technology and health care), engaging numerous regional employers. The groups have identified the need to promote the region as an information technology hub, address company culture to create an employer-of-choice system, enhance soft skills, address long-term technology skills gaps, develop a health care workforce pipeline with K-12 schools and colleges, address talent attraction through exploration of compact licensure/nursing reciprocity, which would allow out-of-state nurses to practice within Michigan; promote leadership/succession planning for health care executive positions; and enhance screening of incoming health care talent to reduce recruit-to-hire ratios.
 - O Workforce: The four Workforce Development Boards (WDB), local elected officials, and Michigan Works! agency directors have been exploring alternatives for aligning, integrating, and consolidating a range of governance and service delivery options. Working to Learn Together funding was used to have the Corporation for a Skilled Workforce provide research on models for consolidation and facilitation of discussions among a workgroup comprised of WDB leadership in the region. Regional workgroup partners have committed to optimizing their collaboration. The four directors are meeting regularly and developing service redesign alternatives for

- their boards to consider. The work of both the joint boards group and the directors is continuing, and we anticipate reaching conclusions about Region 9's approach to redesigning workforce development by early 2015.
- Adult Education: This team, which includes more than 30 stakeholders in adult education, has begun rethinking Region 9's strategy and delivery models for adult education. The team includes local and intermediate school district superintendents, program directors, Michigan Works! agency directors and key staff, and community college leaders. The intent of the redesign is to increase both the reach of adult education and to adopt and expand cutting-edge modalities and delivery approaches that can increase the impact of adult education investments for participating learners. The team is operating under an initial deadline of completing its first-stage plan by January 2015, so as to inform the RFP for Section 107 funding that will need to be issued by Washtenaw Intermediate School District early in 2015 for 2015–2016 services.
- Transportation: The transportation functional team has identified regional transportation goals, objectives, and strategies that directly support region-wide economic prosperity, including opportunities for public-private funding, safety along major highway corridors, support for nonautomobile transportation, and improving the efficiency of freight and passenger movement through and within the region. The team is just getting underway with a Working to Learn Together project that is assessing the transportation needs and desires of talent in the three priority industries (health care, information technology, and manufacturing) identified by the Talent Council.
- Created a Regional Prosperity Initiative website for Region 9 (https://sites.google.com/a/pscinc.com/r9-prosperity-initiative/) which provides an overview of the effort and related tasks, identifies regional stakeholders and timeline, includes an interactive calendar to inform and engage the public, and provides draft documents and project deliverables.
- Drafted an initial regional prosperity strategy focused on advancing regional prosperity in the areas of talent (workforce, industry demands and engagement, adult education) and transportation. The first draft of the strategy will be complete in December, with a final draft of the strategy completed and endorsed by regional entities in January 2015.

The original grant timeline called for the strategy to be completed by September 2014. Because the grant award was not completed until spring 2014, extensions were requested and granted to complete the strategy by January 2015. The functional teams have been identifying measures of success for an ongoing prosperity strategy dashboard, and that dashboard will also be completed in this time frame. Each of the functional teams have begun their Working to Learn Together projects and mini-grant awards have been made to support those projects.

As of the time of this grant application, we are 77 percent through our grant expenditures, although we anticipate all funds will be encumbered by mid-December 2015. We have modified the budget slightly from the original grant application, as was provided to the state in October 2015.

2. NEEDS STATEMENT: Explain the need for a continued collaborative economic strategy in your region. Identify the needs a second grant would fulfill. Acknowledge similar existing projects or agencies, if any, and explain how your proposal differs, and what effort will be made to work cooperatively.

The Regional Prosperity Initiative partners have made significant progress in advancing regional prosperity and identifying the need and options for improving regional services. An additional year of regional collaboration funding is necessary to make progress in the following areas:

- Establishment of a regional council
 - o Broaden engagement in the regional collaborative (particularly the engagement of the business community), evaluate the impact and application of regional council models in Region 9, and ultimately, move from a small regional project management team and individual functional teams to a more formal, multi-stakeholder regional council.
 - O Use the Working to Learn Together approach by having a newly formed regional council convene around one or two high-priority economic development opportunities in the region. This will allow for a rapid, integrated, multidisciplinary approach to addressing a couple key economic development opportunities, giving regional partners the opportunity to start implementing the regional council framework around specific, more confined issues.
- Expanding and building on the success of the functional teams
 - Facilitate further evaluation and development of collaboration/consolidation of services models.
 - o Begin implementing recommended collaboration/consolidation changes.
 - o Address other priority talent, workforce, adult education and/or transportation objectives included in the five-year prosperity strategy.

Many of the goals and strategies included in the prosperity strategy overlap with surrounding regions. In particular, there are overlapping jurisdictions among agencies within Regions 9 and 10 on workforce, adult education, and transportation. As such, each of the functional teams has had, and will continue to have representation from stakeholders in Region 10.

3. LESSONS LEARNED: What lessons will you take from last year's grant process that you will apply this year? How can these lessons inform your strategy for the upcoming year and increase opportunities for success?

It is important to engage stakeholders upfront in the regional strategy development process so people feel engaged in the process as it matures. In Region 9, the initial scope of work was developed with a smaller group of regional partners given time constraints. As we began moving forward with the establishment of functional teams, we quickly realized that a wider range of partners brought a more diverse set of experiences and ideas that are helping to enable stronger collaboration. We have tried to apply these lessons in developing this 2015 RPI proposal by utilizing the broad stakeholder network of the functional teams to generate priority action items to address in next year's grant. Stakeholders will also provide input on when and how to integrate and/or dissolve the current functional teams into the broader regional council and what types of third party facilitation might be most supportive for functional team efforts.

Also, all partners want to see action emerge from their efforts, so in 2015, it is clear that the process and meetings must move beyond network formation and idea generation to implementation of commonly identified and agreed-upon strategies.
