Jackson Area Transportation Authority:


The Jackson Area Transportation Authority (JATA) is requesting the Region 2 Planning Commission approve an amendment to the Transportation Improvement Program to rearrange several Section 5339 projects based on changing priorities, revise the dollar amounts based on the anticipated apportionments, and add a 5307 project. JATA is requesting that the FY 2017 Section 5339 funding for the replacement of two full-sized buses be moved to FY 2019. This allows the FY 2018 project for HVAC upgrades in the administrative/maintenance facility to be moved up to FY 2017. This change is necessary due to changes in how the project is being phased and because the apportionment is expected to be less than originally thought. This would then make room for the administrative office rehabilitation to be moved up from FY 2019 to FY 2018, allowing JATA to complete badly needed upgrades to its administrative facility sooner in exchange for moving back the replacement of full-sized buses. It is worth noting that JATA recently procured replacement engines which will extend the useful life of several full sized buses. JATA would like to maintain the replacement of its radio system in FY 2017 as approved at the previous Commission meeting but is asking that a portion of the project funding be changed to 5307 rather than 5339. This allows more 5339 funds to go to the HVAC project and ensures JATA spends the 1% of federal funding on safety and security projects, as required by the FTA.

**Below is a detailed update on the Jackson Area Transportation Authority's active projects:**

- a. We requested an extension until 9/22/18 to the grant funding the HVAC project to allow some of the funding set aside for A&E to be used for the construction phase. The grant is currently set to expire 9/30/17. This request is currently under review by MDOT. We received approval to award the bid for the A&E phase to Fishbeck, Thompson, Carr & Huber Inc. (FTC&H). The award notification was sent out 4/26/17.
- b. We requested to use portion of extra 5310 funding to replace bus stop signs. We also requested an extension to 9/30/18. These items are under review by MDOT.
- c. We had remaining funds after purchasing the Ford Transit vehicles which we are using to purchase between 20-25 snow tires. The request for quotations was sent out 4/26/17.
- d. We have requested to renovate some of the employee areas of the Transfer Center using the remaining funds from the bathroom renovation project. We did not receive any bids when the request for proposals was initially sent out. We simplified the document and are awaiting MDOT review/approval. The grant is currently set to expire 8/15/17, but we have requested extension to 5/1/18, which is also under review.
- e. We requested to change funding we had originally allocated to replace the parking lot lights at the administration building to instead upgrade our video hard drives. Request submitted 4/4/17 – no updates yet.
- f. Purchased vehicle diagnostic scanners (using miscellaneous shop equipment grant).
- g. We ordered five replacement engines for our full sized buses but have not yet received them.
- h. We sent out a Request for Proposals for our automatic passenger counter/customer interface project. Bids are due at the end of May.

- Michigan Ave Bridge- Agreement at Amtrak. This will not be constructed until 2018 season. Going back in forth with Amtrak on agreement.
- West Michigan Ave from M-99 to N. Concord Road- GI meeting scheduled for May 16, 2017.

**M-60 (EB & WB OV I-94), (PE, SUB & ROW) – Bridge Replacement**

Plan development is just getting started.

**FY 2017**

**I-94 BL/W. Michigan Ave. (Brown St. to Washington / Louis Glick)** – Full concrete pavement roadway reconstruction with water main, lighting and sidewalk replacement. Also includes City of Jackson initiated two-way conversion of Louis Glick Hwy. and Washington. Right-of-Way acquisition is underway. Project was let March 3<sup>rd</sup>, 2017. An unbalanced bid review is underway and the bids should be posted next week. **Contract has been awarded and work is beginning. Should see the detour in place the week of May 8<sup>th</sup>.**

**M-50 (Rives Junction to M-99)** – Micro-surface of existing roadway pavement. Project was let last month. Work is scheduled to begin toward the end of June 2017, with completion in early September 2017.

**I-94 BL (Cooper Street to Dwight Street)** – Single course mill and resurfacing with ADA sidewalk ramp improvements. **Sidewalk ramp work is ongoing. The paving work will start in a few weeks.**

**M-106 (Bunker Hill to East of Sayers Road)** – Single course mill and resurfacing. Work is scheduled to begin in mid-June 2017, with completion in mid-August 2017.

**M-50/US-127 BR (North Street to Boardman)** – Longitudinal joint repair with asphalt mastic and micro-surface materials. **Project was let March 3<sup>rd</sup>, 2017. Work is currently scheduled to start in August.**

**I-94 (M-60 to Calhoun County Line)** – Concrete patching. **Work scheduled to begin the week of May 8<sup>th</sup>.**

**US-127 (Henry Rd. to M-36)** – Single course mill and resurfacing. Design by the Lansing TSC. Project will probably include pavement enhancement test section. **Work is set to begin the week of May 8<sup>th</sup>.**

**M-99 (Railroad St. to Jackson/Eaton County line)** – Fiber Reinforced Bit Membrane with Micro-Surface Work is scheduled to begin in late July 2017, with completion in late September 2017.

**M-50 (US-127 to Napoleon Rd.)** – Two Course Mill and Resurface. **Signal upgrades are mostly done. Joint repairs/lane closures will begin the week of May 8<sup>th</sup>.**

**US-127 (N. of Henry Rd to JCL) - Consultant Road Scoping** – This is a new road scoping project for a major rehabilitation on US-127 (north) in Jackson County. The scope of work will be available for the 2023 Call For Projects.

**I-94BL / M-106 (M-106 (Cooper Street) and I-94BL (Michigan Ave.)** - RR crossing signal upgrades for 2-way conversion. – This is a new force account job number that has been added for the railroad work required for the 2-way conversion. It is part of the 113565/128046 package.

**M-60 (Emerson Rd to Renfrew Rd)** - HMA cold milling and 2 course HMA resurfacing with minor drainage improvements, guardrail upgrade, intersection improvements, and signal modernization. **Plan development is moving forward.**

**I-94 (UN Elm Rd)** – Superstructure repair

## **2045 Travel Demand Model Development**

### **Future Year Socioeconomic Data Review and Approval**

Michigan Department of Transportation (MDOT) staff have finished obtaining and processing local agency comments for the Jackson Area Comprehensive Transportation Study (JACTS) 2045 Travel Demand Model (referred to as “model” throughout the remainder of this document), future year socio-economic (SE) data trends. This data is forecasted from the model base year of 2014, which was approved by the JACTS Technical Advisory and Policy committees in October 2016, to the horizon year of 2045. Interim years of 2025 and 2035 are also listed on these tables.

As part of the Metropolitan Transportation Planning (MTP) process, which is required for obtaining federal funds, future year data is used to identify anticipated travel patterns and potential roadway capacity deficiencies on the road network for the JACTS model area. Proposed capacity road projects are tested as part of the MTP development.

Attached are two tables, provided at the jurisdictional level, for JACTS committee review and subsequent approval, which contain forecasted projections for the following:

- *Table 1 – Demographic Forecasts*
  - Total population totals
  - Group Quarters (GQ) population totals
  - Occupied Housing Unit (OHU) totals
- *Table 2 – Employment Forecasts*
  - Retail sector employment totals
  - Service sector employment totals
  - Other employment (including manufacturing) sector totals
  - Combined employment total

MDOT and R2PC staff is requesting that the JACTS Technical Advisory and Policy committees review the attached tables, and provide any adjustments for MDOT staff to make, prior to the respective May committee meetings.

The final adjustments, if any are provided, will be presented to each committee for approval. The data will then be incorporated into the model.
