#### ITEM 4 AGENCY STATUS REPORTS

Project status updates were presented by City of Jackson, Jackson County Department of Transportation, and the Michigan Department of Transportation. The following project details were provided:

- <u>City of Jackson</u> The Greenwood/Jackson project will likely be completed by the end of June. The
  City is looking at how the signal will be placed for the Steward project. Tree trimming will begin for the
  Elmdale project.
- <u>Jackson County Department of Transportation</u> –The Moon Lake Road bridge project is complete.
  Norvell Road has been paved, and the project will be complete by the end of June. The Michigan
  Avenue bridge project in Parma continues, where work progresses on the perimeter of the project.
  King Road and Springport project bids were received and are being reviewed.
- <u>Michigan Department of Transportation</u> Progress on the I-94 work is continuing. Paving is complete
  under the Cooper Street bridge. Traffic may be allowed on the westbound side after July 4. The
  bridge beams that span I-94 for the M-60 project are being set by the end of June on the westbound
  and southbound ramps. The US-127 from US-12 to Liberty Road project asphalt resurfacing project
  will begin in July.

#### ITEM 4 AGENCY STATUS REPORTS

Project status updates were presented by the City of Jackson, Jackson County Department of Transportation, the Michigan Department of Transportation and Jackson County Airport-Reynolds Field. The following project details were provided:

- <u>City of Jackson</u> Concrete has been placed around the park and has cured for the Greenwood Avenue/Jackson Street project. The project should be complete by the end of June. The City met with Consumers Energy and the consultants to discuss the placement of the traffic signals for the Steward project. The design of the trail has started for the Elmdale project.
- <u>Jackson County Department of Transportation</u> The Moon Lake Bridge and Norvell Road projects are complete. The demolition of the bridge for the Michigan Avenue Bridge project is Parma has been completed. The bids received for the Springport and King road projects were under the engineer's estimate, which will provide cost savings.
- Michigan Department of Transportation Progress on the I-94 work is continuing. Paving is complete
  under the Cooper Street bridge. Traffic may be allowed on the westbound side after July 4. The
  project may be completed by August. The bridge beams that span I-94 for the M-60 project are being
  set by the end of June on the westbound and southbound ramps. The project estimates for the US127 from US-12 to Liberty Road project asphalt resurfacing project came in at 15% under the
  engineer's estimate.
- <u>Jackson County Airport-Reynolds Field</u> The restaurant is open for takeout. A social hour for veterans is taking place. The Airport Board recently approved the installation of an electrical charging station at the airport parking lot.

#### 2019

<u>Greenwood/Jackson Streets: Morrell to Franklin (Urban)</u> – Reconstruct roadway. HRC is the City's consultant on this project. Bailey Excavating is the contractor on this project. **The project is complete.** 

#### 2020

Martin Luther King Jr Blvd: Morrell to Mason (Urban) – Reconstruct roadway. HRC is the City's consultant on this project. Bailey Excavating is the contractor for this project. Phase 1 - Water main is complete, curb and gutter mostly done, roundabout wall is to be poured September 10, paving to be completed by end of September. Phase 2- water main is almost complete with all of Phase 2 to be complete by end of October.

#### 2021

- Morrell Street: Greenwood to Francis (Urban) Reconstruct pavement with curb repairs. HRC is the City's consultant on this project. Submitting plans for GI on October 5 to get a May 2021 through MDOT
- <u>Steward Street: RR to Ganson (Urban)</u> Mill and asphalt resurface with curb repairs and signal reconstruction at Ganson. HRC is the City's consultant on this project. **Submitting plans for GI on October 5 to get a May 2021 through MDOT**
- Bridge CPM (BHT) Denton, Mechanic, North and Trail Rehabilitation on the four bridges. Great Lakes Engineering is the City's consultant on this project. Plans have been submitted for a GI no date set yet.
- <u>Elmdale Trail: Hickory to South St (SR2S)</u> Reconstruction of the existing path to a 10' wide concrete non-motorized path. Rowe Professional Services is the City's consultant on this project. **Gl Meeting was held on September 9, planning on a January letting.**
- <u>Wisner St Traffic Signals (HSIP) Ganson, North and Argyle</u> Replacement of the existing traffic signals at these three intersections with mast arm signals. HRC is the City's consultant on this project. **GI has been held and planning to be in the January 2021 letting.**

#### 2022

E. High Street Bridge over the Grand River - Replacement of the existing bridge superstructure. HRC is the City's consultant on this project.

#### PROJECT REPORT 2020-2023 TIP

#### September 2020

#### 1. Vehicle Procurements

- a. (4) Medium duty vans JATA has evaluated the vans from the previous procurement.
  - i. We have ordered (2) additional medium duty vans from Hoekstra which are similar to the (2) ordered back in May of FY2019. Update from Hoekstra that the vans will be ready for delivery by late October or early November.

#### 2. Bus & Bus Components

a. Replace radio system and bus radios – We successfully had new digital radios installed on all of our transit vehicles including our maintenance vehicles.

#### 3. Facility Upgrades

- a. Surveillance upgrades (cameras, fencing and gates)
  - i. The security camera upgrades will not begin until 2<sup>nd</sup> quarter of FY2021.
  - ii. The fences and gates RFP was sent out on July 30, 2020 and bids are due back to JATA by September 28<sup>th</sup> when we will evaluate each bid closely and choose the award based on specific selection criteria.

#### 4. Grants

- a. JATA received the CARES Act funding in August 2020. With this funding JATA has several projects we will be working to upgrade and keep the administration and maintenance facilities up and operational. A little over 1 million dollars was granted to JATA to begin it's Rides to Wellness Program, which is a Non-Emergency Public Transportation Service aimed at bridging the gap between health and transportation.
- b. There are no other grants currently in process at this time.

#### Michigan Ave Bridge


The beams have been set and post-tensioning completed. They are working on the deck of the bridge now. Completion mid-October, weather permitting.

#### FY 2020

#### **Construction:**

**I-94** (**M-60 to Sargent**) – All mainline and ramp paving work is complete. Remaining work includes removal of temporary barrier wall, shifting traffic back to original lanes, pavement marking, signing, restoration, clean up and other punch list items.

**M-60 bridge over I-94** – Traffic is on the new southbound/westbound M-60 bridge over I-94. Work is underway on the pier and abutment for the northbound/eastbound M-60 bridge.

**US-127** (**Floyd to I-94**) – Concrete pavement repairs from Floyd to I-94. Most pavement repairs have been done. Ramps at Michigan Ave will need to be closed for repairs. Resealing of concrete joints will continue for a few weeks.

**Various traffic signal replacement** – Signal modernization project. Construction is substantially complete.

**M-50** (**Brooklyn village limits**) – Preventative maintenance resurfacing and sidewalk ramps. Concrete work to replace ADA sidewalk ramps and curb repairs is underway. Full depth repairs have been completed and resurfacing of M-50 will happen after all the sidewalk work is complete.

**US-127 near Hart Road** – Install camera for overweight vehicle enforcement. Construction is substantially complete.

**US-127 from US-12 to Cook Road** – Maintenance funded asphalt resurfacing project that will begin later this summer. Paving began the week of 8/31/20 and will last for several weeks.

**Various routes** – pavement markings. Work underway.

Various routes – Crack sealing. Work underway.

I-94 (countywide) – Install cameras and permanent message boards (late 2020 construction). Not started.

#### Design:

M-106 and I-94BL – Non-freeway signing upgrade (2021 construction)

Railroad bridges over Jackson Street and Mechanic Street in downtown Jackson – Bridge replacement (2021 construction).

**I-94 at Elm Road, Lansing Road and West Ave (US-127 west)** – Preparing Design/Build letting package (2021-2023 construction). Also includes resurfacing on US-127 (I-94 to Parnall)

US-127 (Henry to near Ingham Co Line) – state funds only, major resurfacing (future construction)

**I-94 from M-60 to Calhoun County line** – Reconstruction from M-60 to Michigan Ave, major rehabilitation from Michigan Ave to Calhoun County line – 2022-2023 construction.
