ITEM 4 **SMALL URBAN PROGRAM UPDATE**

Mr. Kloha gave an update of the Small Urban program. He announced the funding amounts for FY 2027-2029 projects increased from \$380,000 to \$420,000. It was discovered by another small urban area in the state that federal legislation allows small urban funds to be used on local roads that were constructed before 1991.

ITEM 5 **REVIEW OF CURRENT PROJECTS AND SELECTION OF FY 2027 AND FY 2029 PROJECTS (ADRIAN) AND FY 2028 PROJECT (TECUMSEH)**

Projects were selected for the Adrian Small Urban in FY 2027 and FY 2029, and for the Tecumseh Small Urban in FY 2028. These projects are found in the table below.
